# BOARD OF TRUSTEES Minutes – Special Meeting Thursday, March 6, 2008

#### 1. CALL TO ORDER - ROLL CALL

President Anna L. Piercy called the special meeting of the Anaheim Union High School District Board of Trustees to order at 8:00 a.m.

#### 2. ADOPTION OF AGENDA

Ms. Barnett noted that they communicated at every opportunity to ease the tension and stress of staff members. She noted the work that was done to audit seniority dates, and the fact that "overnotification" of teachers for possible layoffs didn't occur in the AUHSD, as was the case with many other districts, was especially laudable.

#### 5. ITEM OF BUSINESS

## Resolution, Certificated Reduction In Force

On the motion of Mr. O'Neal and duly seconded, following a lengthy discussion, the Board of Trustees adopted Resolution No. 2007/08-HR-05, to reduce or discontinue particular kinds of certificated personnel services, pursuant to Education Code Sections 44949 and 44955. These reductions, or discontinuance in services, are necessitated by significant financial and operational challenges that school districts face because of a state-wide budget crisis. Many California school districts are

responding to the budget issues by issuing layoff notices to certificated and classified staff. Board members will consider classified layoffs at the March 13, 2008, board meeting. The vote follows:
