The Board of Trustees is requested to approve a settlement agreement and general release with Silver Creek Industries, Inc., who was contracted to perform work in conjunction with installation of one modular restroom building each at Western and Savanna High Schools. On August 26, 2010, the Board of Trustees approved the purchase of the buildings, at a cost not to exceed \$450,000, under the terms and conditions of the piggyback bid awarded by the San Gabriel Unified School District. The total amount of \$450,000 included the base buildings costs of \$199,886.30 for each of the two buildings plus an anticipated additional \$50,227.40 allowance for any necessary change orders. There have been no change orders. Therefore, the settlement agreement is for the total base building costs for the two buildings of \$399,777.60. It has recently been discovered that the San Gabriel Unified School District had improperly extended the contract by one year beyond the statutory limit of five years. Since the underlying piggyback contract is no longer valid, approval of this settlement agreement is necessary to permit the District and Silver Creek Industries, Inc. to carry out the terms and conditions that were agreed for the purchase of the two modular restroom buildings. (Originally Funded by RDA) **[EXHIBIT L]**

To avoid the interruption of mental health services, the Orange County Department of Education entered into a memorandum of understanding with the Orange County Health Care Agency to extend mental health services until available funding was depleted, which is estimated to be March 31, 2011. The agreement is necessary for the continued provision of mental health services to special education students, April 1, 2011, through June 30, 2011. The governor's proposed budget for the 2011-12 year, reallocates funding for educationally related mental health services through the mental health care agency. This agreement will be signed following approval by the AUHSD Board of Trustees. (Special Education Funds)

<u>Recommendation</u>: It is recommended that the Board of Trustees approve the agreement.

INDEPENDENT LEARNING CENTER

The Anaheim Secondary Teachers Association (Association) and the Anaheim Union High School District (District) agree that the Independent Learning Center's program has unique staff needs. Therefore, the Independent Learning Center will be staffed through a process rather than a transfer.

The workday at the Independent Learning Center may consist of flexible hours into the early evening. Nights and weekends are excluded from the workday hours for bargaining unit members assigned to the independent Learning Center. The overall workday hours in a typical week will approximate those commonly found at the other sites.

If bargaining unit members are assigned to work in the summer, they will receive their per diem pay and benefits for the additional work year hours.

If a bargaining unit member at the Independent Learning Center is working without a conference period, section 14.8 of the contract applies.

Section 10.6 regarding the lunch period applies to bargaining unit members at the Independent Learning Center.

<u>Anaheim Secondary Teachers Association Initial Proposal</u> <u>to the Anaheim Union High School District</u> <u>for the 2011-12 Collective Bargaining Agreement</u> March 24, 2011

The following proposal is presented to the District for the purpose of beginning collective bargaining for the 2011-12 contract year. The Association reserves the right to add to, subtract from or otherwise modify the articles reopened in this proposal.

ARTICLE 8: LEAVES

8.8 <u>Personal Necessity Leave of Absence</u>

During the 2010-2011 and 2011-2012 school years, unit Unit members may use up to ten (10) days of accumulated sick leave without stating a reason for personal necessity provided the number of personal necessity days does not exceed the number of days of unused sick leave.

- 8.8.1 Personal necessity may be used without prior approval for the reasons listed below. However, the unit member shall make every reasonable effort to comply with District procedures designed to secure substitutes and s/he shall notify the immediate supervisor prior to the absence.
 - 8.8.1.1 Accident or serious illness involving his/her personal property or person or property of his/her immediate family.
 - 8.8.1.2 Court appearance as a litigant or as a witness under order.
 - 8.8.1.3 Religious observances
 - 8.8.1.4 Wedding and graduations for immediate family members. Immediate family for this section shall mean parent, sibling, spouse, or child.
 - 8.8.1.5 Becoming a parent by adoption, surrogate, or paternity
 - 8.8.1.6 Personal necessity may be used for circumstances that meet all of the following criteria: Are of a serious nature, and which the unit member cannot be expected to disregard, and which necessitate the immediate attention of the unit member, and which cannot be accommodated during off-duty hours.

8.11.2 Procedures for Taking Sick Leave

Members of the bargaining unit must notify the District of the absence as soon as the necessity to be absent becomes known to the unit member but in no instance later than 6:30 a.m. of the day of the absence.

A unit member returning from absence must contact the school or site by 2:00p.m. of the day preceding the day of intended return. If s/he is unable to make a determination before 2:00 p.m., the District must be notified not later than 6:30 a.m. the following day. In the event that the District has not been notified of the unit member's intention to return, and accordingly has employed a substitute teacher for the day, the District may require the returning unit member to be charged with one (1) additional day of absence.

ARTICLE 9: TRANSFER PROCEDURES

9.5 Involuntary Transfer

9.5.2 In determining the department from which unit members are to be surplused, the principal will be guided by the best interests of the school provide to the staff a written rationale for his/her decision. The principal's decision may be appealed to the Superintendent or her/his designee. Where it is practicable, the principal will make reasonable effort to retain those teachers who have previously been designated as members of each department in question. No department shall be selected for surplus nor unit member transferred arbitrarily or capriciously.

9.9 Rights of First Return

Involuntary transferees shall have the right to return, in the event of a vacancy, to the school from which s/he was transferred within one and one quarter (1-1/4) years. <u>This right includes vacancies which are less than full-time</u>. Unit members who wish to return will be required to initiate a request to return when the vacancy is posted.

ARTICLE 10: HOURS OF EMPLOYMENT

10.1 Work Year

10.1.3 Unit members shall participate in the site's Back-to-School Night.

10.3 Adjunct Duties

Unit members are required to remain a sufficient amount of time after their last assignment to fulfill necessary adjunct duties such as caring for student academic needs, attending parent or administrative conferences and meetings, and participating in other activities related to the assignment.

Unit members who are required to attend a meeting more than one and a half hours beyond the student day shall be paid at the hourly rate for any time beyond the one and a half hours.

10.4 <u>Supervision Duties</u>

Unit members may be assigned supervision duties during the regular instructional year such as campus supervision and performances, school tutoring programs, athletic events, dances, and detention that occur outside of the regular instructional day. The District shall assign such duties equitably among site unit members based upon choices indicated by the unit members. In no case shall unit members be assigned more than three events or six hours of supervision duty annually.

Supervision duties to be assigned for any instructional year shall be determined and posted at the site before the end of the preceding instructional year.

10.5 <u>Preparation Time</u>

The District shall schedule one (1) daily conference period for each full-time classroom unit member. Unit members shall not be required by principal or designee to give up their preparation and planning time more than two (2) times per year to cover for other teachers without compensation at the hourly rate of pay. <u>Class coverage less than the full period shall count as full class coverage for purposes of counting the number of class coverage periods.</u>

10.5.2 Records of class coverage which include the teacher's signature (Appendix X) shall be kept by the principal or designee and readily available for inspection by any affected unit member regularly assigned to that school site.

10.5.5 After the first two class coverage periods, bargaining unit members shall be compensated one hour's pay for each class coverage, or portion thereof.

10.5.6 Class coverage for any bargaining unit member shall not be required for two consecutive days without the bargaining unit members' consent.

10.7 <u>Teacher Assignments</u>

10.7.2 Three (3) working days prior to the close of the school year the principal or designee shall notify all staff members of their tentative assignments by class periods for the ensuing school year. Changes made subsequent to this notification may be made after the principal/designee has directly consulted by phone or given the unit member five (5) days' notice by certified mail to the last known address of the unit member, of the unit member's opportunity to consult regarding the proposed changes. If inclusion becomes part of an assignment or is removed as part of an assignment, it shall be considered a change and shall require such notice. Failure to respond to the mailed notice shall be deemed a waiver, by the unit member, of such consultation rights.

10.9 <u>Course Preparation</u>

A course preparation is defined as any situation in which the teacher must specifically prepare lessons, tests, or other activities for any class or block having a different course title or having different identified ability levels within a course title.

The District will attempt to shall limit the number of course preparations assigned to each teacher to two (2) course preparations per semester. in the master schedule. Different course preparations within the same class period or block shall be considered as separate course preparations. In the event that more than two (2) preparations must be assigned, the District shall first consult with the unit member involved. A bargaining unit member may initiate and accept the assignment of more than two course preparations per semester.

<u>Move to Article 12:</u> 10.11 Academic Freedom

Academic freedom shall be guaranteed to teachers in order to create an atmosphere of freedom in the classroom which does the following: permits teachers to select the methodology they use in teaching the standards, as long as they continue to receive satisfactory evaluations, permits students and teachers to raise questions dealing with critical issues of the time, and maintains an atmosphere conducive to the study, investigation, presentation, and interpretation of facts.

10.13 Minimum Day

The District shall schedule one (1) student minimum day to be held on the same day that either an Open House or <u>a</u> Back-to-School Night event is held at each site designated as a junior high. The minimum day shall be determined by the site administrator with input from the site unit members.

ARTICLE 11: CLASS SIZE

11.1 Maintain Patterns

The Board will continue its effort to maintain staffing patterns that will avoid state penalties.

11.1 Staffing Ratio

The District will not exceed a staffing ratio of 33:1 per high school and 32:1 per junior high school.

ARTICLE 12: EVALUATION PROCEDURES (see Appendix H)

<u>Replace Article 12 with Appendix H, after bargaining teams' consideration of the Joint Evaluation</u> <u>Task Force recommendations.</u>

12. X Academic Freedom

Academic freedom shall be guaranteed to teachers in order to create an atmosphere of freedom in the classroom which does the following: permits teachers to select the methodology they use in teaching the standards, as long as they continue to receive satisfactory evaluations, permits students and teachers to raise questions dealing with critical issues of the time, and maintains an atmosphere conducive to the study, investigation, presentation, and interpretation of facts.

Move to Article 17:

12.3 Complaints Against Unit Members

12.3.1 If in the opinion of the site administrator or his/her designee a serious complaint has been lodged against an individual teacher by an employee or non employee, the teacher shall be notified within a reasonable period of time and, when practicable, before any students are questioned. Complaints not reported to the teacher under this section shall not be utilized in any evaluation or subsequent disciplinary action.

- 12.3.2 If the complainant wishes to pursue the matter further, the principal will convene a conference between the teacher, the person making the complaint, and the principal or designee for the purpose of resolving the complaint.
- 12.3.3 Complaints that are not resolved at the school level should be directed to the District Superintendent.
- 12.3.4 If after the District Superintendent has responded to the complaint, the complainant is still not satisfied with the answer, further complaint may be made in writing to the Board of Trustees for its investigation and necessary action. All such complaints shall be discussed in closed session.

During the discussion of the charges at all levels, both the complainant and the unit member shall be present.

Move all of Article 12.5 to a separate, new article in the contract.: 12.5 Peer Assistance and Review

ARTICLE 14: WAGES AND ITEMS RELATED TO WAGES 14.2 <u>Salary - Extra-Service Pay</u>

Extra-Service Pay is hereby incorporated as Appendix C of this Agreement.

Extra-Service Pay shall be expressed as a percent of Column II, Step 1 of the 2009-2010 Teachers Salary Schedule (Appendix B-2) and the amount will increase as the Teachers Salary Schedule (Appendix B-1) increases. Any stipends not listed in the Appendices shall be approved by the Association.

- 14.2.1 Department Chairpersons, BTSA Support Providers, Peer Assistance and Review Consulting Teachers, <u>AVID Coordinators</u>, and Peer Assistance and Review Committee Members will be paid monthly with their contract pay. Duties assigned are within the scope of the school day.
- 14.3.2 Initial Salary Placement
- 14.3.5 Any unit member with fifteen (15) complete years of continuous service in the District shall be placed on Step 16 of the salary schedule.
- 14.3.6 Any unit member with twenty (20) complete years of continuous service in the District shall be placed on Step 21 of the salary schedule.
- 14.3.7 Any unit member with twenty-five (25) complete years of continuous service in the District shall be placed on Step 26 of the salary schedule.
- 14.3.8 An additional annual stipend of \$2000 will be paid for an earned doctoral degree from an accredited university.

For purposes of this section, accredited institutions shall be listed in the American Association Collegiate Registrar Admissions (AACRA), Council on Post Secondary Accreditation (COPA), or Association of American Education. Bargaining unit members who attain National Board certification in the field(s) of their assignment will be paid an additional annual stipend of \$2000.

Bargaining unit members who attain National Board certification <u>or American Speech-</u> <u>Language-Hearing Association (ASHA) certification</u> in the field(s) of their assignment will be paid an additional annual stipend of \$2000.

14.3.9 Vertical Movement

- 14.3.9.1 When the years of experience for Initial Placement and the years of experience in the District total fifteen (15), a bargaining unit member shall be placed on Step 16 of the salary schedule.
- 14.3.9.2 When the years of experience for Initial Placement and the years of experience in the District total twenty (20), a bargaining unit member shall be placed on Step 21 of the salary schedule.
- 14.3.9.3 When the years of experience for Initial Placement and the years of experience in the District total twenty-five (25), a bargaining unit member shall be placed on Step 26 of the salary schedule.

ARTICLE 16: PART-TIME EMPLOYMENT/JOB SHARING

- 16.2 Job Sharing
 - 16.2.2.4 In order to advance on the salary schedule the bargaining unit members in the job share must work a minimum of 75% of the 185 work days, which is a total of 139 or more days within two consecutive school years. If a work year is adjusted due to furlough days, the unit member must work a minimum of 75% of the work days within the two consecutive years.

ARTICLE 17: DISCIPLINE

17.1.3 Local Site Folders

17.1.3.2 Materials placed in the local site folder as described in 17.1.3.1 with the exception of item 3 are generally materials known to the unit member. Written "documentation of actions which may lead to official personnel action" will be made known to the unit member prior to use in any official personnel action. <u>Any record of verbal warning will be removed from the local site folder at the end of the school year in which it was given, if discipline has not progressed beyond the verbal warning.</u>

- 17.3 Complaints Against Unit Members
 - 17.3.1 If in the opinion of the site administrator or his/her designee a serious complaint has been lodged against an individual teacher by an employee or non employee, the

teacher shall be notified within a reasonable period of time and, when practicable, before any students are questioned. Complaints not reported to the teacher under this section shall not be utilized in any evaluation or subsequent disciplinary action.

- 17.3.2 If the complainant wishes to pursue the matter further, the principal will convene a conference between the teacher, the person making the complaint, and the principal or designee for the purpose of resolving the complaint.
- 17.3.3 Complaints that are not resolved at the school level should be directed to the District Superintendent.

Brookhurst Street, Suite 204, Anaheim, California 92804.

Article 7 Grievance Procedure

7.1.5 Definitions - Add clarifying language how summer days will be considered.

Article 8 Leaves

8.0 Leaves - Add clarifying language regarding a unit member returning from leave and returning to the same site is subject to displacement due to surplus or RIF similar to active unit members.

- 5.5 [Superseded by Appendix J \underline{H} and Appendix K \underline{I} MOUs] If more than one (1) reassigned unit member is available for special consideration, the principal shall make the selection based on the criteria listed in paragraph 5.2 above.

Article 8: Leaves of Absence

8.17 <u>Bereavement</u>

The District agrees to grant necessary leaves of absence with pay at the unit member's regular rate not to exceed three (3) days, or five (5) if 300 miles or more or out-of-state travel is required, on account of the death of any member of the immediate family of a member of the bargaining unit.

"Member of the immediate family" means the father, mother, father-in-law, mother-inlaw, son, daughter, son-in-law, daughter-in-law, husband, wife, grandmother, grandfather, grandchildren, sister, brother, sister-in-law, brother-in-law, niece, nephew, aunt, uncle of the unit member, and like relatives of spouse, or any person living in the immediate household of the unit member.

Bereavement leave shall be limited to a three (3) or five (5) day period following the date of the death in the immediate family. If such leave of three (3) or five (5) days is not scheduled immediately and consecutively following the death, the unit member will notify his/her immediate supervisor prior to scheduling an alternative plan for bereavement leave. In exceptional circumstances, the Superintendent may grant up to two (2) additional days leave.

Unit members exercising this leave provision shall notify their immediate supervisor as soon as possible and indicate the expected duration of the absence.

Unit members shall be required to complete the standard form provided by the payroll department to verify the reason for the absence.

Article 9: Transfer Procedures

- 9.4 <u>Involuntary Transfer</u>
 - 9.4.1 [Superseded by Appendix J I and Appendix K J MOUs] The parties recognize that it may be necessary to transfer unit members involuntarily because of enrollment adjustments, budgetary restrictions or curriculum needs. Whenever an involuntary transfer becomes necessary at a school, the local administrator shall determine if there are volunteers from the unit members. In designating the transferee, the local administrator shall give one (1) point each for the following criteria: Holders of a PPS Credential and Department Chairperson. Seniority, as outlined in 9.1.2, shall be used to break ties. The principal can exempt a maximum of one (1) counselor position based on the needs of the school.

Article 10: Working Hours

10.4 <u>Inservices</u>

Two (2) days will be provided by management for specific training for counselors. These days will be during the regular 198 day contract period. The inservice training will relate directly to day-to-day counselor services at the school site. <u>Counselors' attendance at these two (2) inservice trainings is not optional and will be supported by site administrators.</u>

- 7. Length of additional paid full-time prior service in a non-certificated position outside of the district.
- 8. <u>If the criterion above does not break a tie a 5-member panel will be chosen, by the</u> <u>APGA Board, to determine which counselor will provide the best service to the district</u> <u>in the best interest of the students and which counselor will be laid off</u>.

While this MOU is in effect, its contents replace existing contract language Article 5.2, 5.5, and Article 9.4.1. All other contract language in Article 5 and Article 9 still applies.

- 2. If there are no volunteers, tie-breaking criteria will be used to determine who will be reassigned.
- 3. Should two or more counselors volunteer to be reassigned; the tie-breaking criteria listed below will apply to determine who has the first opportunity to be reassigned.
- 4. Unit members will be provided an opportunity to list their top three site preferences. This applies to volunteers and non-volunteers. A specific site cannot be guaranteed.
- 5. Once a counselor decides to voluntarily be reassigned, the counselor cannot change this decision.

In the event that there is a tie to determine who will be surplused at a site and moved to another location, the following criteria in priority order will be used:

- 1. Current service as a Lead Counselor
- 2. Seniority as counselor at the site
- 3. Length of previous paid full-time counseling experience with clear PPS credential prior to AUHSD employment.
- 4.—Length of additional paid prior service to District (i.e. teacher, instructional aide, coach, etc.)
- 5.—If the criterion above does not break a tie, a lottery will be used to determine who will be laid off.

- 4. <u>Length of additional paid full-time prior service to the District in a certificated</u> <u>position</u>.
- 5. <u>Length of additional paid full-time prior service in a certificated position</u> <u>outside of the district</u>.
- 6. <u>Length of additional paid full-time prior service to the District in a non-certificated</u> <u>position</u>.
- 7. Length of additional paid full-time prior service in a non-certificated position outside of the district.
- 8. <u>If the criterion above does not break a tie a 5-member panel will be chosen, by the APGA Board, to determine which counselor will provide the best service to the district in the best interest of the students and which counselor will be laid off.</u>

The Association President will be notified of all site openings prior to the District notification of reassignment.

This Settlement Agreement and General Release is entered into on this 24th day of March, 2011 by and between the Anaheim Union High School District, 501 Crescent Way, Anaheim, California 92803 (hereinafter "District"), and Silver Creek Industries, Incorporated, 195 East Morgan Street, Perris, California 92571 (hereinafter "Silver Creek").

WHEREAS, on or about August 26, 2010 the DISTRICT purchased two 30'x32' relocatable restroom buildings (hereinafter "Relocatables") for Western High School and Savanna High School from Silver Creek;

WHEREAS, the purchase of the two Relocatables (\$199,886.30 each) totaled \$399,772.60;

WHEREAS, the District utilized a contract awarded to Silver Creek by the San Gabriel Unified School District, Bid No. 16-04/05, which contract was extended for another year by the San Gabriel Unified School District in March 2010;

WHEREAS, the San Gabriel Unified School District extended its contract with Silver Creek beyond the allowable maximum contract term of five years;

WHEREAS, the District was required to competitively bid for the Relocatables pursuant to Public Contract Code section 20111;

WHEREAS, Silver Creek built, delivered and installed the relocatable restroom building for Western High School in November 2010;

WHEREAS, the District accepted delivery of the Western High School relocatable restroom building and it is currently in use at Western High School;

WHEREAS, Silver Creek is currently building the relocatable restroom building for Savanna High School;

WHEREAS, the District has not paid Silver Creek for the Western High School relocatable restroom building;

WHEREAS, Silver Creek has demanded payment of \$199,886.30 for the Western High School relocatable restroom building;

WHEREAS, Silver Creek has also demanded payment of \$199,886.30 upon delivery and installation of the Savanna High School relocatable restroom building; and

WHEREAS, District and Silver Creek desire to avoid the cost of litigation and resolve this matter without undue expense.

FINAL

NOW, THEREFORE, District and Silver Creek hereby agree as follows:

- 1. All recitals set forth above shall be considered true and correct and are made a part of this Settlement Agreement and General Release.
- 2. District and Silver Creek agree that the Western High School relocatable restroom building has been satisfactorily built, delivered, installed and is currently in use at Western High School.
- 3. District shall pay to Silver Creek on or after March 24, 2011 the amount of \$199,886.30 for the Western High School relocatable restroom building.
- 4. District agrees to pay to Silver Creek the amount of \$199,886.30 for the Savanna High School relocatable restroom building upon satisfactory construction, delivery and installation at Savanna High School.
- 5. In consideration of the payment of the amounts set forth in Sections 3 and 4 to Silver Creek, Silver Creek agrees to diligently perform to completion all work required and to comply with all the terms and conditions set forth in the contract between the District and Silver Creek.
- 6. In consideration of the payment of the amounts set forth in Sections 3 and 4 to Silver Creek, Silver Creek on behalf of itself, its heirs, executors, administrators, successors, assigns, employees, agents and representatives, hereby fully releases and forever discharges the District, its Governing Board, officers, employees, agents and representatives, from any and all claims, demands, causes of action, obligations, damages, attorney's fees, costs and liabilities of any nature whatsoever, whether or not known, suspected or claimed, foreseen or unforeseen, which Silver Creek has had, or now has, or may claim to have had as of the date of this Settlement Agreement and General Release against the District or any of them relating to the purchase of the Relocatables.
- 7. Silver Creek represents and warrants that it has made no assignments and will make no assignment of any claim, demand, right of action, or any right of any kind whatsoever, embodied in any of the subject matter referred to herein and that no other person or entity of any kind had, has or may have any interest in any of the claims, demands, causes of action, obligations, damages, attorney's fees, costs and liabilities referred to herein.
- 8. Silver Creek acknowledges that it may hereafter discover facts different from or in addition to those it now knows or believes to be true with respect to the claims, demands, causes of action, obligations, damages, attorney's fees, costs and liabilities of any nature whatsoever that are the subject of this

Settlement Agreement and General Release. Silver Creek agrees to assume the risk of the possible discovery of additional or different facts and agrees that this Settlement Agreement and General Release shall be and remain effective in all respects regardless of such additional or different facts.

With regards to the settlement and releases as described above, Silver Creek expressly waives any rights under California Civil Code section 1542 which provides:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECTS TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR.

Silver Creek understands and acknowledges the significance and the consequence of the waiver of Section 1542 of the California Civil Code. Should Silver Creek eventually suffer any additional damages, Silver Creek will not be permitted to make any claim for those damages. Silver Creek acknowledges that it intends these consequences even as to claims for damages that may exist as of the date of the Settlement Agreement and General Release of which Silver Creek does not know exists, which, if known, would materially affect Silver Creek's decision to execute the Settlement Agreement and General Release regardless of whether Silver Creek's lack of knowledge is the result of ignorance, oversight, error, negligence or any other cause.

10. Silver Creek acknowledges that has carefully read and fully understands all of the provisions of this Settlement Agreement and General Release and that it is voluntarily entering into this Settlement Agreement and General Release.

NAMING OF FACILITY

The Board of Trustees of the Anaheim Union High School District retains authority for naming <u>and/or renaming</u> all AUHSD facilities and properties. <u>i.e.</u>, <u>e.g.</u>, all buildings; major portions of buildings; stadium and baseball fields and other areas of major assembly or activity; plazas, malls, and other large areas of campus circulation; and all other highly visible facilities and properties.

The Board of Trustees considers the naming of District property an extremely important task. It recognizes that community input and discussion are an integral part of the process. It also recognizes that as time passes, the facts, conditions, and the reasons that went into the decision to name a District property may not be known to future Board members or interested individuals.

All District facilities including: buildings, rooms, property, playing fields, equipment, etc., of the Anaheim Union High School District shall <u>only</u> be named by the Board in accordance with the following criteria:

Criteria

- 1. The geographic area in which the property is located.
- 2. Individuals, living or deceased, who have contributed greatly to the betterment of society and/or the local community, area and/or District.
- 3. Individuals, living or deceased, who have served with distinction in their field of endeavor and represent a positive role model that would reflect with honor on the District.
- 4. Individuals, living or deceased, who have made contributions of state, national or worldwide significance.
- 5. The proposed name shall have significant meaning to the individuals in the area. The Board's goal is to ensure that the naming of facilities honors those who are truly deserving of a permanent memorial and reflective of the purpose and mission of the District.

Procedures for Naming District Facilities

All District facilities including: buildings, rooms, property, playing fields, equipment, etc., of the Anaheim Union High School District shall be named by the Board in compliance with the following procedures:

1. Commencing with the ground breaking of a new District facility, the Board shall may initiate a process to notify the public of the opportunity to submit recommendations for names. The Board reserves the right to establish an appropriate timeline for the

naming process dependent upon the construction timeline of the individual property being considered, as well as other factors deemed necessary for consideration by the Board.

- 2. The Board also reserves the right to determine the need to accelerate or modify a process due to extenuating circumstances.
- 3. For requests to name an existing unnamed building, room, property, playing field, equipment, etc., the process begins with step 4.
- 4. Recommendations to name District facilities shall be submitted to the Superintendent on the official BP 5201-Naming of District Property form, which asks for the name of the individual, his/her accomplishments and contributions, an explanation of the extraordinary nature of these accomplishments and/or contributions, the property to be named, and evidence of school and community support for the recommendation.
- 5. Should the Superintendent and the Board conclude the request to be valid and justifiable, the Superintendent shall establish an Ad Hoc Committee composed of members of the public and staff representing the Anaheim Union High School District.
- 6. Upon formation of the committee, the Superintendent or designee shall call the first meeting of the committee and charge the committee with its task.
- 7. The committee shall, in deliberating the naming of a new District property, give adequate notice of its intent to consider names and shall seek expressions of opinions by all persons in the community wishing to do so.
- 8. The Board defers to the Ad Hoc committee the responsibility to evaluate a proposal(s) within the established criteria set forth in above and encourages the committee to develop specific criteria based on the particular property under consideration, including, but not limited to:

a. What relationship exists between the individual(s) being proposed and the particular facility.

b. How many years did the individual(s) named give service to the students and/or the District.

c. What measurable impact did the individual (s) have on students/district/community.

d. Following appropriate consideration of the request, the committee shall make its report, in writing, with recommendations to the Board.

No facility or property will be named after seated, elected, or appointed officials.

No more than one facility or property in the system shall be named after any one individual.

Once appropriate procedures for naming a facility or property have been followed, the final authority for naming shall rest with the Board.

Renaming District Facilities

The renaming of existing District property shall occur only under extraordinary circumstances and after thorough study.

Dedication Plagues for New Facilities

With the dedication of each new facility in the District, the Board wishes to recognize those individuals who have contributed significantly to the planning and construction of the project. A dedication plaque may be affixed to each new facility and include the following:

- 1. The name of the facility and the year the construction bid was awarded.
- 2. The name of each Board member who was on the Board at the time the construction bid was awarded.

3. The name of the Superintendent at the time the construction bid was awarded.

- 4. The name of the architect.
- 5. The name of the contractor.

AGREEMENT FOR PROVISION OF EDUCATIONALLY-RELATED MENTAL HEALTH SERVICES BETWEEN COUNTY OF ORANGE HEALTH CARE AGENCY AND ANAHEIM UNION HIGH SCHOOL DISTRICT APRIL 1, 2011 THROUGH JUNE 30, 2011

9 THIS AGREEMENT is entered into this 1st day of April 2011, which date is enumerated for 10 purposes of reference only, is by and between the COUNTY of ORANGE (COUNTY) and ANAHEIM 11 UNION HIGH SCHOOL DISTRICT (DISTRICT). This AGREEMENT shall be administered by the 12 County of Orange Health Care Agency (HCA). (Note: The terms "COUNTY" and "HCA" are used 13 interchangeably in this AGREEMENT.)

WHEREAS, Government Code Section 7570 et seq. (also known as "AB 3632") and its implementing regulations remain codified; which shifts state's obligation to county mental health agencies to conduct mental health assessments and to provide necessary mental health-related services, including referral, where appropriate to, residential care-based treatment (placement including the provision of psychotherapy) to students with disabilities, as determined by an individualized education programs ("IEP"), pursuant to Government Code sections 7570, 7572, and 7572.5;

WHEREAS, the State Legislature, in the Budget Act, provides for the pass-through of federal Individuals with Disabilities Education Act ("IDEA") funding for the provision of educationally-related mental health services to students with disabilities as determined by an IEP pursuant to AB 3632 by transmitting the funds to county offices of education from the State Superintendent of Public Instruction;

WHEREAS, in previous fiscal years the Budget Act required each county office of education and county mental health agency to enter into a Memorandum of Understanding for the purpose of transferring these federal IDEA grant funds, subject to the fulfillment of the grant's terms and conditions, to the county mental health agency for educationally-related mental health services as set forth in AB 3632 that are provided to students with disabilities as determined by an IEP;

WHEREAS, in Budget Acts for fiscal years preceding the current Budget Act for fiscal year 2010-11 the state has also provided General Fund support to the counties to provide an array of educationally-related mental health services to students with disabilities pursuant to an IEP. And counties obtained reimbursement for that portion in excess of IDEA funding pursuant to the SB 90 claiming process;

WHEREAS, on October 8, 2010, California Governor Arnold Schwarzenegger ("Governor") 1 exercised the line-item veto in relation to Item 8885-295-0001 of the Budget Act for fiscal year 2010-11 by deleting \$132,941,000 in appropriations scheduled to reimburse local mental health agencies for costs incurred in fiscal years 2004-05 through 2008-09 associated with providing educationally-related mental health services mandated by AB 3632, and in so doing stated "(t)his mandate is suspended";

WHEREAS, the Legislature failed to appropriate state funds in the approximate amount of \$70 million required by Welfare and Institutions Code section 18355 necessary to pay counties for the board and care costs for seriously emotionally disturbed students;

WHEREAS, there are three lawsuits pending in the courts regarding the Governor's veto of the \$132,941,000;

WHEREAS, the Judge in the case of County of Sacramento, et al., v. State of California, et al., Sacramento Superior Court case Number 34-2010-00090983 issued an Order on February 9, 2011 and found that the state mandate upon counties to provide services pursuant to Welfare and Institutions Code section 18355 (residential board and care costs) is suspended based on the Legislature's failure to fund the program;

WHEREAS, the California Court of Appeal, Second Appellate District, Division Three issued a ruling on February 25, 2011 in the case of California School Boards Association, et al., v. Edmund G. Brown Jr., as Governor etc., et al., case number B228680 and held that the Governor's veto was properly exercised, and had the legal effect of suspending operation of the mandate;

WHEREAS, the Parties to this Agreement are unaware whether appeals will be filed in any of the pending lawsuits and therefore do not know what the final conclusion will be on the subject of the status of the AB 3632 mandate for fiscal year 2010-2011;

WHEREAS, the validity of the Governor's suspension of the AB 3632 mandate and the status of the mandate are currently matters of disagreement between the Parties;

WHEREAS, on October 29, 2010, the State Superintendent of Public Instruction ("SPI") announced that the California Department of Education ("CDE") will continue to allocate \$76 million in available federal IDEA funds to maintain essential mental health services for students with disabiliities despite the Governor's suspension of the AB 3632 mandate and his line-item veto of almost \$133 million in mandate reimbursement for services provided by county mental health agencies;

WHEREAS, the SPI stated that the \$76 million to be disbursed by the CDE will ensure mental health services that are included within a student's IEP, pursuant to the IDEA, are appropriately provided during the 2010-11 fiscal year by county mental health agencies consistent with current statute; WHEREAS, the federal IDEA funds are insufficient to entirely fund the AB 3632 services provided

by county mental health for the 2010-11 fiscal year; 34

WHEREAS, in spite of the existing disagreements regarding the status of the AB 3632 mandate, 1 Orange County Department of Education (OCDE) has agreed to pass through fiscal year 2010-2011 2 IDEA funds, as they are received from the State, to reimburse HCA for its provision of educationally-3 related mental health services until approximately \$12 million in IDEA funds are exhausted; 4 WHEREAS, HCA currently estimates that fiscal year 2010-2011 IDEA funds will be exhausted on 5 March 31, 2011; 6 WHEREAS, the Parties have collaborated and enter in to this AGREEMENT in order to: (1) restate 7 their understanding regarding the transfer of the federal IDEA funds from OCDE to HCA which shall be 8 used exclusively for the purpose of funding mental health services identified within an IEP (excepting 9 residential board and care costs), and for which expenses have been or would be incurred in fiscal 10 year 2010-11, and (2) to outline the Parties understanding regarding how these educationally-related 11 mental health services will be paid after IDEA funds have been exhausted. 12 WHEREAS, the Parties wish to avoid additional litigation and avoid unnecessary expenses; 13 NOW, THEREFORE, based on such recitals, and other mutual considerations and promises herein, 14 the Parties agree as follows: 15 // 16

1	I. HCA'S PROVISION OF SERVICES
2	A. HCA agrees to continue to provide educationally-related mental health services from
3	April 1, 2011 through and including June 30, 2011. Educationally-related mental health services for
4	eligible students may include, but not be limited to attending IEP meetings, assessments, individual
5	therapy, group therapy, collateral services, case management, medication management, and residential
6	placement mental health services (excluding board and care).
7	B. HCA agrees to provide monthly "Student by School District" Reports to DISTRICT to review
8	and validate that HCA's Integrated Records Information System ("IRIS") has AB 3632 students
9	documented in the correct district of residence, per the most current IEP found in the county mental
10	health record.
11	C. HCA agrees to provide two "AB 3632 Service Detail" reports to DISTRICT which provide
12	detail of covered mental health services provided to eligible students.
13	D. HCA agrees to seek out and apply for other sources of county, state or federal funding that may
14	be available, including but not limited to, funding from Medi-Cal or the Department of Social Services
15	and consistent with applicable laws. Such funding and/or reimbursement received by HCA for
16	educationally-related mental health services shall offset any amount DISTRICT is required to fund
17	under this Agreement. The accounting of expenditures to DISTRICT shall reflect the costs of services,
18	the amount and payment of any offsets, and the net cost for the reimbursement.

20	II. <u>RESIDENTIAL PLACEMENT AND PAYMENT OF ROOM AND BOARD</u>
21	During the term of this AGREEMENT, HCA will make recommendations for students requiring

1	IV. <u>REIMBURSEMENT FOR AB 3632 SERVICES</u>
2	AFTER IDEA FUNDS ARE EXHAUSTED
3	DISTRICT will reimburse HCA for the provision of educationally-related mental health services
4	(which exclude the cost of residential board and care) that exceed the amount of federal IDEA funds
5	allocated and distributed from CDE to OCDE for AB 3632 Services for fiscal year 2010-2011. This
6	amount shall be referred to as "Additional Costs." Current estimates suggest that IDEA funds will be

8	A. DISTRICT will reimburse HCA for Additional Costs within twenty-nine (29) days of receipt of

11	B. The Additional Costs shall be for educationally-related mental health services described in
12	Subparagraph I.A., noted above, and all allowable costs as noted in Subparagraph V. below.

14	V. <u>SUBMISSION OF CLAIMS</u>
15	A. HCA will submit a claim for services under this AGREEMENT by July 1, 2011 to DISTRICT.
16	DISTRICT shall reimburse HCA, on a full cost recovery basis, for all costs incurred in providing
17	educationally-related mental health services which are not reimbursed by Medi-Cal or Early and
18	Periodic Screening, Diagnosis, and Treatment ("EPSDT"). Payment must be received by
19	July 29, 2011. Reimbursable costs include both direct and indirect costs as previously allowed under the
20	AB 3632 program.
21	B. HCA will use its annual Mental Health Cost Report to reconcile all services provided during the
22	term of this AGREEMENT and will provide a final reconciliation to DISTRICT by January 23, 2012 or
23	sooner if possible. Parties agree to pay any difference of costs as determined by the final reconciliation
24	without waiver of its right to seek use of the dispute resolution process or other remedies provided by
25	law. C. If requested by DISTRICT, COUNTY agrees to submit estimated monthly expenditures for
26	April 2011 and May 2011 by May 13th and June 10th respectively. The estimated monthly
27	expenditures will be in the same general format as the claim, but include only totals for the categories of
28 29	expenditure.

VI. MISCELLANEOUS

A. If a court of competent jurisdiction reaches a final and binding decision that the Governor lacked authority to suspend the AB 3632 mandate, or a court, the Legislature or the Governor make a final determination that the State Department of Mental Health and its local county mental health agencies are responsible for providing AB 3632 Services during fiscal year 2010-11 and find that State reimbursement will be available, the Parties agree that HCA will reimburse DISTRICT for any Additional Costs that have been paid to HCA for provision of educationally-related mental health services during the term of this AGREEMENT within ninety (90) days.

B. If reimbursement is due pursuant to Section VI.A. above, HCA will submit an SB 90 claim to the State for AB 3632 costs incurred during fiscal year 2010-11. If requested, DISTRICT will reasonably cooperate with HCA's efforts to seek reimbursement from the State of California through the SB 90 claiming process.

C. Parties agree that neither side is waiving its legal arguments, remedies or right to reimbursement
in connection with this Agreement or as to the effect of the Governor's suspension of the AB 3632
mandate and line item veto of funding.

D. Referrals and assessment reports. 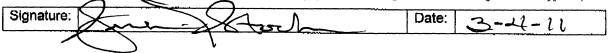

School holidays and non-student days will be excluded unless the district requests that our clinician attend a specific meeting or in-service. Additional services can be provided if deemed necessary by district administration and/or PCSS, Inc.
- PAYMENT TERMS: This district will reimburse PCSS, Inc. at the rate of \$82.00/hour, 7 hours per day for the total hours billed. Payment is due within 30 days of invoice. Contract can be cancelled or substantially reduced with 30 days notice.
- 3. District hereby acknowledges that PCSS, Inc. independent contractors are screened, hired, and trained at considerable time and expense by PCSS, Inc. District further acknowledges that PCSS, Inc. independent contractors have entered into a contractual relationship with PCSS, Inc. to provide the above services for District. District agrees that it, or any third party associated, directly or indirectly, with the District, will not hire, solicit, contract, or otherwise seek to employ PCSS, Inc. independent contractors, directly or indirectly, in such a way as to interfere with the contractual relationship between PCSS, Inc. independent contractors and PCSS, Inc., and for a period of one (1) year after the completion of an independent contractors contract with PCSS, Inc. District agrees that, acknowledging the contractual services provided by PCSS, Inc. and PCSS, Inc. subcontractors, should District desire to employ or otherwise hire the services of a particular PCSS, Inc. independent contractor within one (1) year after conclusion of an independent contractors contract, District will not directly hire said independent contractor, but will contact PCSS, Inc. for a continuation of said independent contractors services. The period of extension is from February 1, 2011, to April 1, 2011.

10.3 Waiver Request-School Accountability Report Cards

On the motion of Mrs. Smith, duly seconded and unanimously carried, following discussion, the Board of Trustees approved the waiver request to the State Board of Education (SBE) to allow an additional 60 days to publish the School Accountability Report Cards (SARCs). The District is required to publish SARCs for each school, within the District, by February 1 of each year. The SARCs contain information on student enrollment, school safety, facilities, teachers, support staff, instructional materials, school finance, student performance, accountability, school completion/postsecondary preparation, and professional development. The waiver is necessary because the SBE recently revised the SARC template and reduced the amount of data that they provide to districts to complete the SARCs. District staff needs additional time to collect the necessary data that the state no longer provides.

10.4 *Memorandum of Understanding, AFSCME*

On the motion of Mr. O'Neal, duly seconded and unanimously carried, the Board of Trustees approved the memorandum of understanding (MOU) with the American Federation of State, County and Municipal Employees Association (AFSCME) regarding transportation work assignments when equalization is not in effect. This MOU is an extension of the agreement that was initially Board approved on December 10, 2009. It stipulates an agreement with AFSCME, in which the District and AFSCME agree to temporarily modify Article 15.7 and the process used to assign work during winter break, spring break, summertime, and other periods when equalization is not in effect. This agreement sunsets on June 30, 2011, unless both parties mutually agree to extend it.

10.5 Memorandum of Understanding, ASTA

On the motion of Mrs. Piercy, duly seconded and unanimously carried, the Board of Trustees approved the memorandum of understanding (MOU) with the Anaheim Secondary Teachers Association (ASTA). This MOU is related to the restoration of two furlough days, reducing

the total number of furlough days as previously agreed to in the 2010-11 bargaining agreement.

10.6 Memorandum of Understanding, CSEA

On the motion of Mr. O'Neal, duly seconded and unanimously carried, the Board of Trustees approved the memorandum of understanding (MOU) with the California School Employees Association (CSEA). This MOU is related to the restoration of two furlough days, reducing the total number of furlough days as previously agreed to in the 2010-11 bargaining agreement.

10.7 Memorandum of Understanding, APGA

On the motion of Mrs. Piercy, duly seconded and unanimously carried, the Board of Trustees approved the memorandum of understanding (MOU) with the Anaheim Personnel and Guidance Association (APGA). This MOU is related to the restoration of two furlough days, reducing the total number of furlough days as previously agreed to in the 2010-11 bargaining agreement.

10.8 Memorandum of Understanding, AFSCME

On the motion of Mr. O'Neal, duly seconded and unanimously carried, the Board of Trustees approved the memorandum of understanding (MOU) with the American Federation of State, County and Municipal Employees Association (AFSCME). This MOU is related to the restoration of two furlough days, reducing the total number of furlough days as previously agreed to in the 2010-11 bargaining agreement.

10.9 Unrepresented Employees, Restoration of Furlough Days/Workdays for 2010-11

On the motion of Mrs. Piercy, duly seconded and unanimously carried, the Board of Trustees approved the restoration of two furlough days for unrepresented employees including certificated and classified management/administration and confidential employees. The Board previously took action on July 15, 2010, to issue furlough days for these employees as a cost-saving measure for the 2010-11 year. The specific days to be restored will be March 14, 2011, and April 22, 2011, which will be student instructional days. The salary schedule for these employees will be adjusted accordingly to reflect the reduction of two furlough days and the increase in two work days for the 2010-11 year. In addition, two furlough days will be restored in the administration contracts for the superintendent, deputy superintendent, assistant superintendents, and counsel.

10.10 Revised 2010-11 Student/Teacher Calendar with Adjusted Furlough Days

On the motion of Mr. O'Neal, duly seconded and unanimously carried, the Board of Trustees adopted the revised 2010-11 Student/Teacher Calendar reflecting restored furlough days as agreed to by the collective bargaining agreements with AFSCME, ASTA, APGA, and CSEA. The 2010-11 Student/Teacher Calendar was previously adopted at the Board meeting on March 3, 2010, and re-adopted with furlough days on May 19, 2010. The revised Student/Teacher Calendar restores the Non-Student/Non-Teacher furlough days on March 14, 2011, and April 22, 2011. The students' school year will be adjusted from 176 days to 178. The teachers' work year will be adjusted from 179 days to 181 days. Of the 181 days, 178 will be instructional days and three days will be non-instructional days. This calendar will be shared with the parents, students, and community. The restored furlough days were selected as a result of recent funding increases. A separate calendar designating all furlough days for each employee unit will be adjusted and distributed to employees and the community.

10.11 **Revised Employee Work Calendar and Furlough Agreements**

On the motion of Mr. O'Neal, duly seconded and unanimously carried, the Board of Trustees adopted the revised 2010-11 work calendar agreements with AFSCME, ASTA, APGA, CSEA, and ALTA designating adjusted furlough days. The employee work calendar was previously adopted with furlough days on May 19, 2010, and the revised calendar restores March 14, 2011, and April 22, 2011, as regular work days. Additionally, the revised calendar reflects furlough days as previously agreed to in the 2010-11 bargaining agreement for AFSCME unit members.

10.12 Independent Contract Agreement for Facilitator Services

On the motion of Mr. O'Neal, duly seconded and unanimously carried, the Board of Trustees ratified the independent contract agreement with Richard Thome of Leadership Associates to provide facilitator services. The purpose of this agreement was to provide a workshop for the Board of Trustees and superintendent. Service was provided January 13, 2011, at a cost not to exceed \$1,700. (General Funds)

10.13 *Revised Board Policy, First Reading*

On the motion of Mr. O'Neal, duly seconded and unanimously carried, following discussion, the Board of Trustees reviewed the first reading of revised Board Policy 6604, Administrative Substitute Salary Schedule. The proposed change reflects additional authority by the superintendent to exempt substitute administrators from this policy as necessary. As the policy currently reads, a substitute shall receive 75 percent of Step 1 for the job classification, which the substitute is replacing. The current policy often subjects substitutes to a decrease in pay while assuming additional responsibilities since 75 percent of Step 1 is often lower than a substitute's previous or current salary. The revised policy will authorize the superintendent to adjust the substitute administrator's salary, not to exceed the maximum for the assigned classification, to more fairly compensate substitutes.

It was the consensus of the Board of Trustees that the policy be returned for a second reading with changes that indicate the superintendent may recommend the exemption of substitutes and may propose a salary that more fairly compensates substitutes.

10.14 *Revised Board Policy, First Reading*

On the motion of Mr. O'Neal, duly seconded and unanimously carried, following discussion, the Board of Trustees reviewed and approved revised Board Policy 8200, Section 504. The proposed changes reflect updates in the law and the terms of a voluntary resolution agreement with the Office of Civil Rights.

10.15 Request to Bid Network Access Control Using PCC 20118.2

On the motion of O'Neal, duly seconded and unanimously carried, the Board of Trustees approved the request to bid network access control using Public Contract Code (PCC) 20118.2. The Information Systems Department will be embarking upon a project to implement network access control for posture assessments, device quarantining, device awareness, and guest networking. The technology is essential to isolate computers infected with malware. The topology component is a critical prerequisite for the introduction of student, consultant, presenter, and other stakeholder devices. This technology will better position the District to control rogue computers from accessing the network.

Approval of this action enabled the District to proceed with a competitive request for proposal, under PCC 20118.2, for various types of network equipment, and services District-Wide. PCC 20118.2 states, "Due to the highly specialized and unique nature of technology, telecommunications, related equipment, software, and services, because products and

materials of that nature are undergoing rapid technological changes, and in order to allow for the introduction of new technological changes into the operations of the school District, it is in the public's best interest to allow a school district to consider, in addition to price, factors such as vendor financing, performance reliability, standardization, life-cycle costs, delivery timetables, support logistics, the broadest possible range of competing products and materials available, fitness of purchase, manufacturer's warranties, and similar factors in the award of contracts for technology, telecommunications, related equipment, software, and services."

10.16 Request to Bid Student Assessment System Using PCC 20118.2

On the motion of Mrs. Piercy, duly seconded and unanimously carried, the Board of Trustees approved the request to bid student assessment system using Public Contract Code (PCC) 20118.2. The District has been using an online data and assessment management system, which provides schools and the District with information to monitor student progress and to evaluate program effectiveness. It would be in the District's best interest to pursue a competitive process for the purpose of potential cost savings and enhancing current practices in procuring an assessment management system.

Approval of this action enabled the District to proceed with a competitive request for proposal, under PCC 20118.2, for technology, telecommunications, related equipment, software, and services District-Wide. PCC 20118.2 states, "Due to the highly specialized and unique nature of technology, telecommunications, related equipment, software, and services, because products and materials of that nature are undergoing rapid technological changes, and in order to allow for the introduction of new technological changes into the operations of the school District, it is in the public's best interest to allow a school district to consider, in addition to price, factors such as vendor financing, performance reliability, standardization, life-cycle costs, delivery timetables, support logistics, the broadest possible range of competing products and materials available, fitness of purchase, manufacturer's warranties, and similar factors in the award of contracts for technology, telecommunications, related equipment, software, and services."

10.17 <u>Agreement, The Regents of the University of California/Family Medicine</u> (For Resident Education)

On the motion of Mr. O'Neal, duly seconded and unanimously carried, following discussion, the Board of Trustees approved the agreement between the Regents of the University of California on behalf of the University of California, Irvine, School of Medicine (UCI) and the District for services to be provided January 20, 2011, through June 30, 2013. Under this agreement, UCI will station four resident medical students (residents) at the District to provide free medical services to District students. The UCI residents are licensed physicians pursuing advanced specializations at the UCI School of Medicine. The program will be housed in the District's nurse's office, which is now located in room one of the Language Assessment Center at the District Campus facility. The residents' schedules and services will be coordinated by the District Nurse Practitioner Kathy Strobel. All services will be rendered at no cost to the District.

11.1 <u>Agreements</u>

11.1.1 Intern Program, University of Redlands

The Board of Trustees approved an agreement with the University of Redlands for Student Teaching, July 1, 2011, through June 30, 2013. University students will meet with school site master teachers to be involved in the student's preparations for student teaching. This agreement provides opportunities for the student teacher to observe, participate, assist, and teach in the master teacher's classroom for one semester. Master teachers will model to the student teacher effective planning, instruction, and management strategies, as well as discuss these strategies with the student teacher. Services will be provided at no cost to the District.

11.1.2 <u>North Orange County Regional Occupational Program, Career Guidance</u> <u>Specialist Personnel</u>

The Board of Trustees ratified an agreement with the North Orange County Regional Occupational Program (NOCROP) for career guidance specialist personnel. This is a long standing agreement whereby the District agrees to provide District personnel, as requested by NOCROP, to service programs maintained by NOCROP in the District, July 1, 2010, through June 30, 2011. The income to the District will be approximately \$729,487.93. This is an increase of \$33,332.93 from last year. (General Funds)

11.1.3 <u>North Orange County Regional Occupational Program, Reverse Link</u> <u>Instruction</u>

The Board of Trustees ratified an agreement with the North Orange County Regional Occupational Program (NOCROP) for reverse link instruction. This is a long standing agreement whereby the NOCROP agrees to provide appropriately credentialed personnel, as requested by the District, to service instructional programs maintained by the District, July 1, 2010, through June 30, 2011. The expense to the District will be approximately \$93,566.00. This is a \$10,249.00 increase from last year. (General Funds)

11.1.4 Third Party Claims Administration Agreement

The Board of Trustees approved an agreement with Claim Retention Services, Inc. (CRS) to administer claims for the property and liability claims program and student accident insurance program. The term of the agreement is February 1, 2011, through January 31, 2012. The annual fixed rate fee for property and liability claims that occur within the self insured retention of the District is not to exceed \$21,000. Administration of claims beyond the self insured retention would be invoiced on a time and expense basis and reimbursement requested from the excess joint powers authority. Additional investigative and mileage expenses would be on an as needed basis. Claim administrative services for the student accident insurance program would not exceed \$3,000.

11.2 2010-11 Second Quarterly Report, Williams Uniform Complaints

The Board of Trustees accepted the Williams Uniform Complaints Second Quarterly Report, October 1, 2010, through December 31, 2010, as required by Education Code Section 35186. The report will be submitted to the Orange County Department of Education. The report summarizes all complaints relative to adequate textbooks and instructional materials, teacher vacancies or misassignments, facilities conditions, and intensive instruction and services for students who have not passed the California High School Exit Examination (CAHSEE) by the end of the 12th grade. There were no complaints during this quarter.

11.3 *Educational Consulting Agreements*

11.3.1 Parent Institute for Quality Education

The Board of Trustees approved the educational consulting agreement with Parent Institute for Quality Education (PIQE). PIQE will conduct a nine-week program, consisting of weekly evening training sessions, for Orangeview Junior High School parents. The purpose of the training is to increase parents' involvement in their child's educational process. Additionally, the training promotes a partnership between parents and the school. Services include: telephone calls to all households for the recruitment of parent participants, curriculum development for nine parent seminars, and required instructional materials, such as binders and lesson plans for the 80 parent participants, February 1, 2011, through March 29, 2011, at a cost not to exceed \$6,400. (EIA/LEP Funds)

11.3.2 Parent Institute for Quality Education

The Board of Trustees approved the educational consulting agreement with Parent Institute for Quality Education (PIQE). PIQE will conduct a nine-week program, consisting of weekly evening training sessions, for Katella High School parents. The purpose of the training is to increase parents' involvement in their child's educational process. Additionally, the training promotes a partnership between parents and the school. Services include: telephone calls to all households for the recruitment of parent participants, curriculum development for nine parent seminars, and required instructional materials, such as binders and lesson plans for the 200 parent participants, January 25, 2011, through March 15, 2011, at a cost not to exceed \$15,000. (Title I Funds)

11.4 2009-10 Audited Annual Financial Report

On the motion of Mr. Brandman, duly seconded and unanimously carried, following a report by the auditor and a lengthy discussion, the Board of Trustees accepted the audited annual financial report for the 2009-10 fiscal year. In accordance with Education Code Section 41020.3 by January 31 of each year, the governing body of each local education agency shall review, at a public meeting, the annual audit for the prior year. This review shall be placed on the agenda of the meeting pursuant to Education Code Section 35145. The District's audit was performed by the audit firm of Vavrinek, Trine, Day and Co., LLP.

11.5 Consolidated Application, Part II

On the motion of Mr. Brandman, duly seconded and unanimously carried, following discussion, the Board of Trustees approved the Consolidated Application, Part II, for the 2010-11 year. This is the final submission of the two-part application. Every year, the District is required to submit the Consolidated Application, for the following federal categorical programs: Title I, Title II, Title III, and Title IV. The following state categorical programs are also included: EIA-LEP, School Safety and Violence Prevention, and TUPE. These funds are designated for specific programs and activities designed to reduce the achievement gap. Many certificated and classified school personnel, and most professional development activities, are supported by these programs.

11.6 2010-11 Single Plan for Student Achievement

On the motion of Mr. O'Neal, duly seconded and unanimously carried, following discussion, the Board of Trustees approved the 2010-11 Single Plan for Student Achievement, for each school site, as mandated by the state. Each plan, recently distributed to the Board of Trustees, includes information pertaining to site curriculum, instruction, professional development, parent activities, and budget expenditures.

11.7 <u>Agreement, North Orange County Community College District Teacher Preparation</u> <u>Pipeline Grant</u>

The Board of Trustees approved the subcontractor agreement #10-090-005 with the North Orange County Community College District (NOCCCD). This agreement provides \$14,000 in supplemental funding for professional development for 25 math, science, and Health Science and Medical Technology pathway instructors from Savanna, Western, and Magnolia high schools, and Oxford Academy. Teachers will participate in three after-school work sessions and will receive an extra-service stipend, not to exceed \$560 per teacher. The purpose of the work sessions is to develop contextual learning curricula and materials for use with career technical education students at the four high schools. The term of this agreement is from February 15, 2011, through June 30, 2011, at no cost to the District.

11.8 <u>Agreement, 2010-11 Earned Income Tax Credit (EITC) Campaign Community</u> <u>Partner Stipend Agreement</u>

On the motion of Mrs. Smith, duly seconded and unanimously carried, following discussion, the Board of Trustees approved the 2010-11 Earned Income Tax Credit (EITC) Campaign Community Partner Stipend agreement with the Orange County United Way (OCUW). The EITC Campaign is a community-based effort designed to assist low-income families and individuals, and the elderly, with preparing and submitting their federal and state tax return claims. Anaheim Union High School District accounting pathway students at Cypress, Katella, Kennedy, Loara, and Savanna high schools, and their accounting teachers, are members of the Volunteer Income Tax Assistance (VITA) program. The accounting students and the teachers have prepared for, and passed, basic and intermediate taxation certifications through the United States Internal Revenue Service (IRS). Collectively, these students and their accounting teachers will host several "Community Tax Days" with VITA either at Cypress High School or the District Campus. To offset the cost of hosting these Community Tax Days, OCUW will provide a stipend of \$6,000 to the District accounting pathway program. The term of this agreement is January 21, 2011, through May 15, 2011, at no cost to the District.

11.9 Rejection of Liability Claim

The Board of Trustees rejected a liability claim that was filed on November 9, 2010, and identified as AUHSD 11-01. After review, staff determined that the claim was not a proper charge against the District. This claim alleges personal loss and/or injury.

11.10 Rejection of Claim

The Board of Trustees rejected the claim from Fast-Track Construction, Inc., dated November 19, 2010, against the Anaheim Union High School District, found that the claim was not a proper charge against the District as provided in Government Code Section 915(a), and authorized staff to send a notice of the rejection pursuant to Government Code Section 913.
