9. **ITEMS OF BUSINESS**

9.1 <u>Resolution 2009/10-B-14, PARS Supplemental Retirement Plan</u> ACTION ITEM (Roll Call Vote)

The Board of Trustees is requested to adopt Resolution No. 2009/10-B-14, which provides a retirement incentive offer to eligible certificated employees who wish to voluntarily exercise their option to separate from district service. This plan is being made available through Public Agency Retirement Services (PARS) and is a supplementary retirement plan, a retirement incentive program supplementing STRS. The plan will be effective April 1, 2010, through August 1, 2015.

There are a variety of requirements and benchmarks that must be met for the district to ultimately participate in the program, all of which will be fully explained to interested parties in pre-retirement seminars and presentations. If a level of program participation, acceptable to the district, has not been reached as of the enrollment deadline, the district may withdraw the incentive before May 21, 2010.

9.2 <u>Agreement for Administrative Services for the PARS Supplementary</u> ACTION ITEM <u>Retirement Plan</u>

Participation in a retirement incentive plan for eligible certificated employees requires a formal agreement for administrative services with the firm that was selected to oversee the program. The firm, Public Agency Retirement Services (PARS) was selected as the administrator after a comparison with another company. This program is intended to save district funds. (General Funds)

9.3 <u>Resolution 2009/10-HR-05, Concerning the Reinstatement of</u> <u>Classified Positions from the 2009-10 Reduction in Force</u> (Roll Call Vote) ACTION ITEM

On December 10, 2009, the Board of Trustees took action to reduce particular kinds of services provided by classified employees. This action was necessitated by the state-wide budget crisis and significant reductions in district revenues. District staff carried out the board's decision by using a selection process that involved seniority, in accordance with the requirements of the Education Code.

The Board of Trustees is requested to adopt Resolution No. 2009/10-HR-05, to reinstate ten classified positions from the 2009-10 Reduction in Force. The reinstatement of these specific Food Service Assistant I, Food Service Assistant III, and Food Service Assistant III–Bilingual positions is due to the confirmation of the multi-track school sites and the multi-track school calendar of the Anaheim City School District. The reinstatement process will be in accordance with the requirements of the Education Code. These positions will be funded from Food Services funds and will be offered to employees by seniority. **[EXHIBIT A]**

It is recommended that the Board of Trustees adopt Resolution No. 2009/10-HR-05, by a roll call vote.

9.4 <u>Resolution No. 2009/10-HR-06, Economic Uncertainty</u> ACTION ITEM (Roll Call Vote)

The Board of Trustees is requested to adopt Resolution No. 2009/10-HR-06, Economic Uncertainty, due to the anticipated adverse financial conditions of the state and the impact on the district budget. The resolution states that the district reserves the right to negotiate with the collective bargaining employee units, a reduction in salary and/or furloughs that correspond to a reduction in salary for the 2010-11 year. **[EXHIBIT B]**

Recommendation:

It is recommended that the Board of Trustees adopt Resolution No. 2009/10-HR-06, by a roll call vote.

9.5 Waiver Application, Local Educational Agency Title I, Part A ACTION ITEM

The Board of Trustees is requested to approve the Local Educational Agency, Title I, Part A, Waiver Application. The district, in accordance with California Department of Education (CDE) guidelines, is submitting an application to waive eight federal program requirements. The most significant of these waivers would allow for additional flexibility in the use of American Recovery and Reinvestment Act (ARRA) Title I, and Title I, Part A, funding, and eliminate the 15 percent carryover restriction on Title I, Part A, funding, from 2009-10 to 2010-11. This would allow the district to continue to fund portions of the Lesson Design Specialist project and provide Title I programs at Savanna and Western High Schools. (ARRA Title I, and Title I, Part A, Funds) **[EXHIBIT C]**

Recommendation:

It is recommended that the Board of Trustees approve the waiver application.

9.6 <u>Application, Universal Grant, After School Education and Safety</u> ACTION ITEM (ASES) Program

The Board of Trustees is requested to approve the After School Education and Safety (ASES) Program Universal Grant application, submitted by the district, on behalf of Lexington Junior High School and the Boys and Girls Club of Cypress. The stated program objectives for ASES are to "merge school reform strategies with community resources in efforts to improve assistance to students and to broaden the base of support for education in the critical hours after school." The grant is designed to provide tutoring in literacy development, academic enrichment, counseling services, and physical fitness activities for students, after school, in a safe and constructive environment. The amount requested for this grant is \$151,200. **[EXHIBIT D]**

Recommendation:

It is recommended that the Board of Trustees approve the application.

9.7 Public Hearing, Disclosure of Request for Waiver, QEIA

INFORMATION ITEM

The Board of Trustees is requested to hold a public hearing on the request for a waiver to California Education Code section 52055.740 (C)(i), to increase the ninth grade Quality Education Investment Act (QEIA) pupil to teacher targets from 21:1 to 23:1 at Anaheim High School.

Although this is an information item only, requiring no formal action by the board, it is recommended that the Board of Trustees formally open the public hearing to provide the public an opportunity to speak on the proposed request.

9.8 <u>Waiver Request, Quality Education Investment Act (QEIA) Class</u> ACTION ITEM <u>Size Reduction for Anaheim High School</u>

The Board of trustees is requested to approve the QEIA class size reduction waiver request for Anaheim High School. The Anaheim High School QEIA ninth grade class size reduction target for August 30, 2010, through June 30, 2014, is 21:1 for all core content areas: English language arts, reading, mathematics, science, and history/social science. The district would like to submit a waiver request to the State Board of Education to increase the targets from 21:1 to 23:1. Anaheim High School may not be able to meet the 21:1 target through June 30, 2014, because California budget reductions and funding flexibilities reduced supplementary funds that were being used to facilitate the class size reduction target. Specifically, the Morgan Hart ninth grade class size reduction program was in place when the ninth grade QEIA target was established, and it is no longer available. (QEIA Funds) **[EXHIBIT E]**

Recommendation:

It is recommended that the Board of Trustees approve the waiver request.

9.9 <u>Settlement Agreement and General Release, Harbor Construction</u> ACTION ITEM <u>Company, Inc.</u>

The Board of Trustees is requested to approve a settlement agreement and general release with Harbor Construction Company, Inc., which was contracted to perform work in conjunction with the Katella High School Modernization. Upon completion of the contract, a dispute arose with Harbor Construction Company, Inc. over the terms and conditions of the contract. Subsequently, Harbor Construction Company, Inc. filed a claim with the district. The district and Harbor Construction Company, Inc. now desire to settle all disputes. (Facilities Funds) **[EXHIBIT F]**

Recommendation:

It is recommended that the Board of Trustees approve the settlement agreement and general release.

9.10 Rejection of Liability Claim

The Board of Trustees is requested to hold a public hearing on the Anaheim Union High School District's initial contract proposal to the American Federation of State, County and Municipal Employees for the 2010-11 year.

Although this is an information item, requiring no formal action by the Board of Trustees, it is recommended the board formally open a public hearing to provide the public an opportunity to speak on the proposal.

10.1 *Educational Consulting Agreement Amendments*

10.1.1 University of California, Irvine, Irvine Math Project

Approve the educational consulting agreement amendment with the University of California, Irvine (UCI), Irvine Math Project. Staff development currently being provided will be expanded to include Sycamore and Walker Junior High School math teachers. This will assist them in addressing the needs of seventh grade students who require intensive math instruction in pre-algebra. UCI will also work with a district-wide committee of eighth grade algebra teachers to develop a curriculum guide designed to better meet the needs of students who struggle with the current basic algebra curriculum. This new curriculum guide will be put in place for 2010-11, and will also include quarterly common assessments used to measure the level of students' mastery of essential algebra standards. The original agreement for \$9,680 was approved on August 27, 2009. In order to continue to provide additional services, a \$5,000 increase to the original agreement amount is requested, with a maximum amount not to exceed \$14,680, through June 30, 2010. (Title I Funds) **[EXHIBIT K]**

10.1.2 Sylvan Learning Center (Learning Partners, Inc.)

Approve the educational consulting agreement amendment with Sylvan Learning Center (Learning Partners, Inc.), a Supplemental Educational Services (SES) provider. The services are a requirement of the of the No Child Left Behind Act (NCLB) of 2001, for schools in years two through five of Program Improvement (PI). Ball, Brookhurst, Dale, Orangeview, South, and Sycamore Junior High Schools are offering the supplemental tutoring services to low-income students. An increase in the original amount for Sylvan Learning Center is requested as a result of increased parent demand. Services are being provided November 2, 2009, through May 15, 2010. The original amount approved on October 15, 2009, was not to exceed \$15,000. The amended amount is at a cost not to exceed \$50,000. (Title I Funds) **[EXHIBIT L]**

Recommendation:

It is recommended that the Board of Trustees approve the educational consulting agreement amendments.

10.2 <u>Agreement Amendments, The Regents of the University of California MESA Schools</u> <u>Program (MSP)</u>

Approve the amendment to Agreement No. 06-MSP-14, which will now be Agreement No. 06-MSP-20, and approve the amendment to Agreement No. 06-MSP-20 with The Regents of the University of California MESA Schools Program (MSP). This amendment is required to reduce the funding level of the agreement by \$15,000. The reduction in funds is required because "MESA Day" will not be hosted by the Orange County MESA program, which is currently housed in the AUHSD. These funds are to be transferred to another MESA program that will host the "MESA Day" event. The reduction in funds will not affect the MESA program and will not have a negative impact on the district's budget. **[EXHIBIT M]**

Recommendation:

It is recommended that the Board of Trustees approve the agreement amendments.

10.3 Sole Source Justification, TeleParent Educational Systems, LLC

The exhibit to this item is a consulting agreement with Jack Plicet to analyze our school-tohome communication needs, and develop a sole source justification document for TeleParent Educational Systems', LLC.

The contract total with TeleParent Educational Systems, LLC will be approximately \$86,546 for three years, which is over the bid limit (PCC 20111). A sole source justification is needed when only one source is available and the estimated value of the purchase exceeds the bid limit.

The TeleParent Educational Systems, LLC TeleParent System facilitates attendance calling, emergency broadcasting, and community outreach from the classroom to the administrative office. The purpose of the system is to communicate student information to parents and guardians and to communicate pertinent school information to the community. TeleParent uses human-translated scripts in 23 languages to facilitate multilingual, one-way communications from teachers and administrators to the community.

The contract total with TeleParent Educational Systems, LLC will be approximately \$86,546 for 3 years, which is over the bid limit (PCC 20111). A sole source justification is needed when only one source is available and the estimated value of the purchase exceeds the bid limit.

TeleParent Educational Systems, LLC has a one-of-a-kind system and should be considered a sole source vendor. Sole sourcing a vendor will require an opinion from an independent consultant with expertise regarding the product, or service, required by a district. The opinion should be obtained from an impartial third party prior to an award of any contract. Jack Plicet has performed this service for several school districts in Orange County, including Garden Grove Unified School District. He will analyze our school-to-home communication needs and develop a sole source justification document. This document will then be brought to the Board of Trustees for approval. Services will be provided April 2, 2010, through June 2, 1010, at a cost not to exceed \$2,100.

If the Board of Trustees approves the consulting agreement with Mr. Plicet, and if the board subsequently approves the sole source justification document, then the purchasing department will precede with the purchase of the TeleParent Educational Systems', LLC, TeleParent System, for school-to-home communication. (Title I Funds) **[EXHIBIT N]**

Recommendation:

It is recommended that the Board of Trustees approve the consulting agreement.

10.4 Award of Bid, for Financial Auditing Services

Approve the award of bid for auditing services to Vavrinek, Trine, Day & Company, LLP. California school districts are required to have an annual financial and compliance audit, per Education Code Sections 14500 et al., and 41020. Financial and compliance audits are performed in accordance with generally accepted audit standards issued by the Comptroller General of the United States and Standards and Procedures for Audits of California K-12 Local Education Agencies issued by the California Education Audit Appeals Panel. The auditor audits the financial statements, categorical programs, and various financial procedures in order to express an opinion on the financial statements and position of the district.

A competitive request for proposal was used by district staff to determine the contractor best qualified to provide auditing services. It is recommended that the award of bid be given to Vavrinek, Trine, Day & Company, LLP to provide financial auditing services to the district commencing April 2010, at a cost not to exceed \$45,000 per year. (General Funds)

Recommendation:

It is recommended that the Board of Trustees approve the award of bid.

10.5 Agreement, Stutz Artiano Shinoff and Holtz, A.P.C.

Approve an increase in the retainer agreement with Stutz Artiano Shinoff and Holtz, A.P.C., consultant for legal services, by \$200,000, for a total cost not to exceed \$350,000. The original agreement, which is included as the exhibit, was approved on June 25, 2009, for the 2009-10 year in the amount of \$150,000. This increase is necessitated by unexpected legal assistance including layoff matters. (General Funds) **[EXHIBIT 0]**

Recommendation:

It is recommended that the Board of Trustees approve the increase in the amount of the agreement.

10.6 Meal Agreement Addendum, TWLC Foundation

Approve the meal agreement addendum, with inter-agencies each year, in order to continue providing meals to the Tiger Woods Learning Center (TWLC) Foundation. This agreement generates income from the meals served. The price charged for lunch will increase from \$2.50 to \$2.75. Services will be provided April 1, 2010, through June 30, 2011. **[EXHIBIT P]**

Recommendation:

It is recommended that the Board of Trustees approve the addendum to the agreement.

PARS SUPPLEMENTARY RETIREMENT PLAN

RESOLUTION NO. 2009/10-B-14

April 1, 2010

On the motion of Trustee ______ and duly seconded, the following resolution was adopted:

WHEREAS, it is determined to be in the best fiscal interest of the district and its employees to provide a retirement incentive offer to eligible employees who wish to voluntarily exercise their option to separate from district Service;

WHEREAS, there is no cash option available to employees in lieu of this retirement incentive offer;

WHEREAS, Public Agency Retirement Services (PARS) has made available to the district a Supplementary Retirement Plan, a retirement incentive program supplementing STRS/PERS, and qualifying under the relevant sections of Section 403(b) of the Internal Revenue Code;

WHEREAS, the district, pursuant to applicable policy and/or a collective bargaining agreement, desires to adopt the Supplementary Retirement Plan and to fund the incentive through non-elective employer, post-employment contributions to the PARS designated 403(b) provider.

NOW THEREFORE, BE IT RESOLVED,

- 1. That the Board of Trustees of the district hereby adopts the PARS Supplementary Retirement Plan, as part of the District Retirement Program, effective April 1, 2010; and
- 2. In order for the district to reach stated fiscal goals, a minimum number of participants must enroll in the retirement incentive plan. If a minimum is not reached, the district may withdraw the retirement incentive. If the district withdraws the retirement incentive, resignations may be rescinded; and
- 3. The Board of Trustees of the district hereby appoints the Assistant Superintendent, Business, or his/her successor or his/her designee as the district's plan administrator; and
- 4. The district's PARS plan administrator is hereby authorized to execute the contracts, custodial agreement facilitating the payment of contributions to the 403(b) arrangement, and other legal documents related to a trust or the plan on behalf of the district and to take whatever additional actions are necessary to maintain the district's participation in the plan and to maintain compliance of any relevant regulations issued.

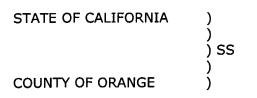

AGREEMENT FOR ADMINISTRATIVE SERVICES

This agreement ("Agreement") is made this 1st day of April, 2010, by and between Phase II Systems, a corporation organized and existing under the laws of the State of California, doing business as Public Agency Retirement Services (hereinafter "PARS") and the Anaheim Union High School District ("Agency").

WHEREAS, the Agency is desirous of retaining PARS to act as administrator to assist the Agency in the establishment of early retirement incentive programs through contributions to purchase an *IRC* 403(b) fixed annuity contract (the "Plan"), for the benefit of Agency's eligible employees and their beneficiaries ("Participants"); and

WHEREAS, the Agency wishes for PARS to provide consulting, analytical, and administrative services necessary to implement the Plan; and

WHEREAS, in performance of the duties set forth hereinafter PARS shall designate from time to time a custodian to receive Employer Plan contributions ("Custodian") designated for Participants; and

WHEREAS, in performance of the duties set forth hereinafter, PARS shall designate from time to time an insurance company for the purpose of paying Participants a specified amount of money on a regular basis over a specified period of time ("Insurance Company") pursuant to the terms of the Plan.

NOW THEREFORE, the parties agree:

- 1. Services. PARS will provide the services pertaining to the Plan as described in the exhibit attached hereto as "Exhibit 1A" ("Services") in a timely manner, subject to the further provisions of this Agreement.
- 2. Fees for Services. PARS will be compensated for performance of the Services as described in the exhibit attached hereto as "Exhibit 1B".
- 3. **Payment Terms.** Payment for the Services will be remitted directly from contributions for the Plan that Agency has made to the Custodian unless otherwise stated in Exhibit 1B. In the event that the Agency chooses to make payment directly to PARS, it shall be the responsibility of the Agency to remit payment directly to PARS based upon an invoice prepared by PARS and delivered to the Agency. If payment is not received by PARS within thirty (30) days of the invoice delivery date, the balance due shall bear interest at the rate of 1.5% per month.
- 4. Fees for Services Beyond Scope. Fees for services beyond those specified in this Agreement will be billed to the Agency at the rates indicated in the PARS standard fee schedule in effect at the time the services are provided and shall be payable as described in Section 3 of this Agreement. Before any such services are performed, PARS will provide the Agency with written notice of the subject services, terms, and an estimate of the fees therefore.

- 5. Information Furnished to PARS. PARS will provide the Services contingent upon the Agency's providing PARS the information specified in the exhibit attached hereto as "Exhibit 1C" ("Data"). It shall be the responsibility of the Agency to certify the accuracy, content and completeness of the Data so that PARS may rely on such information without further audit. It shall further be the responsibility of the Agency to deliver the Data to PARS in such a manner that allows for a reasonable amount of time for the Services to be performed. Unless specified in Exhibit 1A, PARS shall be under no duty to question Data received from the Agency, to compute contributions made to the Plan, to determine or inquire whether contributions are adequate to meet and discharge liabilities under the Plan, or to determine or inquire whether contributions made to the Plan are in compliance with the Plan or applicable law. In addition, PARS shall not be liable for non-performance of Services if such non-performance is caused by or results from erroneous and/or late delivery of Data from the Agency. In the event that the Agency fails to provide Data in a complete, accurate and timely manner and pursuant to the specifications in Exhibit 1C, PARS reserves the right, notwithstanding the further provisions of this Agreement, to terminate this Agreement upon no less than ninety (90) days written notice to the Agency.
- 6. Suspension of Contributions. In the event contributions are suspended, either temporarily or permanently, prior to the complete discharge of PARS' obligations under this Agreement, PARS reserves the right to bill the Agency for Services under this Agreement at the rates indicated in PARS' standard fee schedule in effect at the time the services are provided, subject to the terms established in Section 3 of this Agreement. Before any such services are performed, PARS will provide the Agency with written notice of the subject services, terms, and an estimate of the fees therefore.
- 7. **Records.** During the term of this Agreement, and for a period of five (5) years after termination of this Agreement, PARS shall provide duly authorized representatives of the Agency access to all records and material relating to calculation of PARS' fees under this Agreement. Such access shall include the right to inspect, audit and reproduce such records and material and to verify reports furnished in compliance with the provisions of this Agreement. All information so obtained shall be accorded confidential treatment as provided under applicable law.
- 8. Confidentiality. Without the Agency's consent, PARS shall not disclose any information relating to the Plan except to duly authorized officials of the Agency and to parties retained by PARS to perform specific services within this Agreement. The Agency shall not disclose any information relating to the Plan to individuals not employed by the Agency without the prior written consent of PARS, except as such disclosures may be required by applicable law.
- 9. Independent Contractor. PARS is and at all times hereunder shall be an independent contractor. As such, neither the Agency nor any of its officers, employees or agents shall have the power to control the conduct of PARS, its officers, employees or agents, except as specifically set forth and provided for herein. PARS shall pay all wages, salaries and other amounts due its employees in connection with this Agreement and shall be responsible for all reports and obligations respecting them, such as social security, income tax withholding, unemployment compensation, workers' compensation and similar matters.
- 10. Indemnification. PARS and Agency hereby indemnify each other and hold the other harmless, including their respective officers, directors, employees, agents and attorneys, from

any claim, loss, demand, liability, or expense, including reasonable attorneys' fees and costs, incurred by the other as a consequence of PARS' or Agency's, as the case may be, acts, errors, or omissions with respect to the performance of their respective duties hereunder.

- 11. **Compliance with Applicable Law.** The Agency shall observe and comply with federal, state and local laws in effect when this Agreement is executed, or which may come into effect during the term of this Agreement, regarding the administration of the Plan. PARS shall observe and comply with federal, state and local laws in effect when this Agreement is executed, or which may come into effect during the term of this Agreement, regarding the term of this Agreement, regarding Plan administrative services provided under this Agreement.
- 12. Applicable Law. This Agreement shall be governed by and construed in accordance with the laws of the State of California. In the event any party institutes legal proceedings to enforce or interpret this Agreement, venue and jurisdiction shall be in any state court of competent jurisdiction.
- 13. Force Majeure. When satisfactory evidence of a cause beyond a party's control is presented to the other party, and nonperformance was unforeseeable, beyond the control and not due to the fault of the party not performing, a party shall be excused from performing its obligations under this Agreement during the time and to the extent that it is prevented from performing by such cause, including but not limited to: any incidence of fire, flood, acts of God, acts of terrorism or war, commandeering of material, products, plants or facilities by the federal, state or local government, or a material act or omission by the other party.
- 14. **Ownership of Reports and Documents.** The originals of all letters, documents, reports, and data produced for the purposes of this Agreement shall be delivered to, and become the property of the Agency. Copies may be made for PARS but shall not be furnished to others without written authorization from Agency.
- 15. **Designees.** The Agency, or their designee, shall have the authority to act for and exercise any of the rights of the Agency as set forth in this Agreement, subsequent to and in accordance with the written authority granted by the Governing Board of the Agency through adoption of a Resolution, a copy of which writing shall be delivered to PARS. Any officer of PARS, or his or her designees, shall have the authority to act for and exercise any of the rights of PARS as set forth in this Agreement.
- 16. Notices. All notices hereunder and communications regarding the interpretation of the terms of this Agreement, or changes thereto, shall be effected by delivery of the notices in person or by depositing the notices in the U.S. mail, registered or certified mail, return receipt requested, postage prepaid and addressed as follows:
 - (A) To PARS: PARS; 4350 Von Karman Avenue, Suite 100, Newport Beach, CA 92660; Attention: President
 - (B) To Agency: Anaheim Union High School District; 501 Crescent Way, Anaheim, CA 92803; Attention: Assistant Superintendent of Business

Notices shall be deemed given on the date received by the addressee.

17. Term of Agreement. This Agreement shall remain in effect for the period beginning April 1, 2010 and ending August 1, 2015 ("Term"). This Agreement will continue unchanged for

successive twelve-month periods following the Term unless either party gives written notice to the other party of the intent to terminate prior to ninety (90) days before the end of the Term.

- 18. Amendment. This Agreement may not be amended orally, but only by a written instrument executed by the parties hereto.
- 19. Entire Agreement. This Agreement, including exhibits, contains the entire understanding of the parties with respect to the subject matter set forth in this Agreement. In the event a conflict arises between the parties with respect to any term, condition or provision of this Agreement, the remaining terms, conditions and provisions shall remain in full force and legal effect. No waiver of any term or condition of this Agreement by any party shall be construed by the other as a continuing waiver of such term or condition.
- 20. Attorney's Fees. In the event any action is taken by a party hereto to enforce the terms of this Agreement, the prevailing party therein shall be entitled to receive its reasonable attorney's fees.
- 21. **Counterparts.** This Agreement may be executed in any number of counterparts, and in that event, each counterpart shall be deemed a complete original and be enforceable without reference to any other counterpart.
- 22. Headings. Headings in this Agreement are for convenience only and shall not be used to interpret or construe its provisions.
- 23. Effective Date. This Agreement shall be effective on the date first above written, and also shall be the date the Agreement is executed.
- 24. Further Acts. The Parties shall execute all such further and additional documents as shall be reasonable, convenient, necessary, or desirable to carry out the provisions of this Agreement, including but not limited to any Custodial Agreement as shall be required by PARS and /or the Custodian.

EXHIBIT 1A

<u>SERVICES</u>

PARS will provide the following services for the Anaheim Union High School District:

- 1. Plan Consultation Services:
 - (A) Meeting with Agency personnel to discuss the impact to the Agency of implementing a Plan;
 - (B) If appropriate, completing a fiscal analysis, based on data and assumptions provided by Agency, to determine the fiscal feasibility of a Plan;
 - (C) Meeting with Agency personnel to discuss the fiscal analysis and receive feedback on the analysis, data, and assumptions made;
 - (D) Making appropriate revisions to the fiscal analysis as directed by Agency.
- 2. Plan Installation Services:
 - (A) Meeting with Agency personnel to finalize plan provisions, implementation timelines, benefit communication strategies, data reporting and contribution submission requirements;
 - (B) Providing the necessary analysis and advisory services to finalize these elements of the Plan;
 - (C) Providing the documentation needed to establish the Plan for review by Agency legal counsel.
- 3. Plan Administration Services:
 - (A) Monitoring the receipt of Plan contributions made by the Agency to the Custodian, based upon information received from the Agency and the Custodian;
 - (B) Performing periodic accounting of custodial assets, including the allocation of employer contributions, payments to the Insurance Company, investment activity and expenses (if applicable), based upon information received from the Agency and/or Custodian;
 - (C) Acting as ongoing liaison between the Participant and the Agency in regard to the Plan, which shall include use by the Participants of toll-free telephone communication to PARS;
 - (D) Producing benefit illustrations and processing enrollments;
 - (E) Coordinating the processing of contribution payments to the Insurance Company pursuant to authorized written Agency certification of eligibility, authorized direction by the Agency, and the provisions of the Plan, and, to the extent possible, based upon Agency-provided Data;
 - (F) Coordinating actions with the Custodian as directed by the Plan Administrator within the scope of this Agreement.

- 4. PARS is not licensed to provide and does not offer tax, accounting, legal, investment or actuarial advice. In providing the services specified above, PARS will retain qualified professional service providers at its cost as it deems necessary if the service lies outside its area of expertise.
- 5. Any analysis provided by PARS is subject to the receipt of accurate information and assumptions as may be provided by Agency. The Agency is responsible for integrating the PARS analysis into any Agency budgetary analysis or decision-making processes. The fiscal projections in the PARS analysis are dependent upon future experience conforming to the assumptions used and the results will be altered to the extent that future experience deviates from these assumptions. It is certain that actual experience will not conform exactly to the assumptions used in the analysis.

PARS will be compensated for performance of Services, as described in Exhibit IA based upon the following schedule:

Upon implementation of the Plan associated with this Agreement, the Agency agrees to pay an administration fee equal to four and one-quarter percent (4.25%) of all premiums made by the Agency on behalf of Participants in the subject Plan, subject to a \$5,000.00 minimum per year for five years. Fees will be billed to the Custodian as contributions are made by the Agency, and it will be the responsibility of the Custodian to pay those fees from the custodial assets of the Plan.

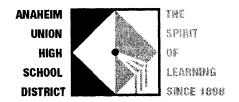

When the Anaheim Union High School District applied for QEIA funding at Anaheim High School, the revenue limit per student was \$6,358.36. The current revenue limit per student, adjusted for the deficit factor, is \$5,751.39 per student. The \$606.97 reduction per student, from the district's general fund, has necessitated the elimination of Morgan-Hart ninth-grade class-size reduction at all AUHSD high schools. The district had no choice but to exercise maximum flexibility with Morgan-Hart, a tier-three categorical fund. The elimination of Morgan-Hart at Anaheim High School represents a loss of \$923,520 per year, which paid for approximately 9 English language arts teachers.

Morgan-Hart was being implemented at Anaheim High School when QEIA targets were established, and the ninth-grade pupil to teacher target was determined to be 21:1, by the third year of QEIA program implementation. The base year was calculated at 26:1, instead of 31:1, if Morgan-Hart class size reduction had not been included in the calculation.

AUHSD is committed to continued implementation of the QEIA program at Anaheim High School, in which 74.7% of students are low-income. This scenario has been made more difficult given recent revenue limit reductions, and the subsequent termination of Morgan-Hart at Anaheim High School. The district is requesting that the State Board of Education support the district's efforts, and allow for an adjusted ninth-grade QEIA target of 23:1.

SETTLEMENT AGREEMENT AND GENERAL RELEASE

This Settlement Agreement and General Release is entered into this 1st day of April, 2010, by and between the Anaheim Union High School District, 501 Crescent Way, Anaheim, California 92803 (hereinafter "District"), and Harbor Construction Co., Inc., 15550 Rockfield Blvd., Suite B-100, Irvine, CA 92618 (hereinafter "Contractor").

RECITALS

WHEREAS, on, or about, March 27, 2007, the District opened competitive bids for Bid No. 2007-18, Katella High School Modernization, and, on, or about, April 26, 2007, the governing board of District awarded bid to Contractor, and, on, or about, April 27, 2007, District and Contractor executed a contract to complete project, (hereinafter "Contract"); and,

WHEREAS, Contract had an original total value of \$10,585,000 and, District ordered changes to Contract via change orders and work orders, (hereinafter "Change Orders"), totaling \$852,183 ; and,

WHEREAS, on, or about February 12, 2009, Contract was accepted by the governing board of District as complete, and, on, or about, February 17, 2009, District recorded a notice of completion of Contract with the County Recorder; and,

WHEREAS, after recording of the notice of completion, Contractor claimed and demanded payment for additional costs related to Work Orders No. 27, No. 99, No. 102, No. 130 and No. 136 for a total amount of \$50,219 as indicated on Exhibit A (hereinafter "Claim"); and,

WHEREAS, District has determined that demand for additional compensation by Contractor for Work Orders No. 27, No. 99, and No. 130 clearly does not have merit, and, that Work Order No. 136 may reasonably be reduced from a credit to District in the amount of \$27,900 to a credit to District in the amount of \$14,364; and,

WHEREAS, District and Contractor desire to avoid the cost of litigation and to resolve this matter without undue expense.

AGREEMENT

NOW, THEREFORE, District and Contractor hereby agree as follows:

1. District shall pay the Contractor the sum of \$13,536 (thirteen thousand five hundred thirty six and no cents) as full and final payment for Contract.

District will issue a check made payable to Contractor within thirty (30) days of execution of this Settlement Agreement and General Release;

2. In consideration of the payment of the amount as set forth in (1.) above, Contractor on behalf of itself, its heirs, executors, administrators, successors, assigns, employees, agents and representatives, hereby fully releases and forever discharges District, its governing board, officers, employees, agents and representatives, from any and all claims, demands, causes of action, obligations, damages, attorney's fees, costs and liabilities of any nature whatsoever, whether or not known, suspected or claimed, foreseen or unforeseen, which Contractor has ever had, now has, or may claim to have, as of the date of this Settlement Agreement and General Release against the District or any of them by reason of any act or omission concerning any claims relating to or arising out of the Contract, including, but not limited to, Change Orders.

3. Contractor represents and warrants that it has made no assignments and will make no assignment of any claim, demand, right of action, or any right of any kind, whatsoever, embodied in any of the subject matter referred to herein and that no other person or entity of any kind had, has, or may have, any interest in any of the claims, demands, causes of action, obligations, damages, attorney's fees, costs and liabilities referred to herein.

4. Except as set forth by this Agreement, the District, on behalf of its Governing Board, officers, parents, subsidiaries, joint-ventures, successors, assigns, employees, agents and representatives herby fully releases and forever discharges Contractor, its parents, subsidiaries, joint-ventures, successors, assigns, employees, agents and representatives from any and all claims, demands, causes of action, obligations, damages, attorney's fees, costs and liabilities of any nature whatsoever, whether or not known, suspected or claimed, foreseen or unforeseen, which district has ever had, now has or may claim to have had as of the date of this Agreement against Contractor or any of them by reason of any act or omission concerning any claims relating to or arising out of the work related to the Contract.

4b. District and Contractor agree that specifically excluded form the Releases in Section 2 above are any liabilities, demands, claims and causes of actions which arise from or relate to warranties or latent or other construction defects or defective workmanship in the Contract or any third party against the District arising out of Contractor's work on the Contract, to the extent applicable, and that District and Contractor shall not be precluded from bringing any action at law or in equity arising from or relating to such matters. This includes District's rights pursuant to California Code of Civil Procedure section 337.15, to the extent applicable. District represents that as of the date of this Agreement, it is unaware of any warranty issues or latent construction defect claims, or third party actions threatened or pending arising out of construction of Contract. This Agreement is not intended to and does not extend or revive any warranty or claim by District or a third party.

5. Contractor acknowledges that it may hereafter discover facts different from or in addition to those they now know or believe to be true with respect to the claims, demands, causes of action, obligations, damages, attorney's fees, costs and liabilities of any nature whatsoever that are the subject of this Settlement Agreement and General Release. Contractor agrees to assume the risk of possible discovery of additional or different facts and agrees that this Settlement Agreement and General Release shall be and remain effective in all respect regardless of such additional or different facts.

6. Contractor expressly waives any rights under California Civil Code section 1542 which provides:

"A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECTS TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."

Contractor understands and acknowledges the significance and the consequence of the waiver of Section 1542 of the California Civil Code. Should Contractor eventually suffer any additional damages, Contractor will not be permitted to make any claim for those damages. Contractor acknowledges that it intends these consequences even as to claims for damages that may exist as of the date of the Settlement Agreement and General Release of which Contractor does not know exist, which, if known, would materially affect Contractor's decision to execute the Settlement Agreement and General Release regardless of whether Contractor's lack of knowledge is the result of ignorance, oversight, error, negligence or any other cause.

7. This Agreement is the result of compromise and shall never at any time for any purpose be considered an admission of liability or responsibility on the part of District or Contractor, and District and Contractor continue to deny such liability and to disclaim such responsibility.

8. Contractor acknowledges that it has been given the opportunity to consult with independent legal counsel, that is has carefully read and fully understands all of the provisions of this Settlement Agreement and General Release and that it is voluntarily entering into this Settlement Agreement and General Release.

The following is in response to your correspondence dated June 26, 2009 in regards to the arbitrary billing reduction of \$22,319 via Work Orders are # 99, 102, and #130 and the District's withhold in the amount of \$27,900.00 via WO #136.

WO #99 – District imposed reduction of \$3,934.00: I stand corrected. It is acknowledged that WO #26 was replaced by WO #27. However the changes in work originally outlined in WO #26, CPE #137, was incorporated into WO #27. The WO #99 reduction in cost is a duplication. Also in previous negotiations WO #99 was revised to zero change in cost.

WO #102 District imposed reduction of \$16,135.00: Harbor's explanation and backup to this matter was provided in its May 26^{th} letter.

WO #130 District imposed reduction of \$2,250.00: The IOR was mistaken in his assessment and Harbor took exception to it. Harbor's position on this matter remains unchanged.

In addition, it is clear that the above mentioned WOs were previously made null and void by the District on the basis that these items were never on the Districts list of open Credit Work Order items.

WO #136 District imposed reduction of \$27,900.00: It is and always has been Harbor's position that it complied with the requirements and intent of the documents and that the District's charge is unwarranted.

In summation Harbor is still of the opinion that the District has wrongfully withheld funds totaling \$50,219.00 of which it is asked that they are immediately released to Harbor. If the District takes exception to this request it is requested that we meet to discuss and resolve these matters once and for all.

PURPOSE STATEMENT

- 13. Researches a variety of information (e.g. current processes, best practice strategies, methods, guidelines, etc.) for the purpose of developing new programs and/or master plans.
- 14. Composes a wide variety of documents in both written and electronic formats (e.g. reports, memos, letters, policies, etc.) for the purpose of documenting activities, providing written reference and/or conveying information.

OTHER FUNCTIONS

Performs other related duties, as assigned, for the purpose of ensuring an efficient and effective work environment.

The District may reopen negotiations for 2010-2011, if any changes negatively impact the District's federal and/or state revenue funding levels, including but not limited to the District's base revenue limit of \$5729.59, categorical funding and applicable categorical flexibility provisions in the state budget act, deficit factor, state apportionment deferrals, and/or state mandates.

CSEA may reopen negotiations for 2010-2011 to reduce the furlough days, if any changes which positively impact the District's federal and/or state revenue funding levels, including but not limited to the District's base revenue limit, categorical funding and applicable categorical flexibility provisions in the state budget act, deficit factor, state apportionment deferrals, and/or state mandates.

This is a one-year agreement that does not modify any other article in the existing contract and does not set precedent for any future negotiations.

This agreement will sunset on June 30, 2011.

The University of California, Irvine (UCI) Math Project will expand the scope of the math project with the Anaheim Union High School District to include additional staff development to math teachers at Walker Junior High School and Sycamore Junior High School. These teachers have elected to teach a specially-designed mathematics course for seventh grade students who require intensive math instruction in pre-algebra. Walker Junior High School and Sycamore Junior High School teachers will implement the two-period math model currently used with great success at Dale Junior High School with students who are four or more years behind in math.

UCI will also work with a district-wide committee of eighth grade algebra teachers to develop a curriculum guide designed to better meet the needs of students who struggle with the current basic algebra curriculum. This new curriculum guide will be put in place for the 2010-11 school year and will be accompanied by quarterly common assessments used to measure the level of a student's conceptual mastery of the essential standards of algebra.

All other terms and conditions of the original agreement will remain in force.

V. <u>COST/BUDGET/PAYMENT/INTEREST</u>

A. Program Cost and Funding

B. Payment

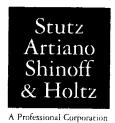

ATTORNEY - CLIENT RETAINER AGREEMENT

This document (the "Agreement") is the written fee contract that California law requires lawyers to have with their clients. We, Stutz Artiano Shinoff & Holtz, APC ("Attorneys"), agree to provide legal services to Anaheim Union High School District, (the "District") on the terms set forth below:

1. SCOPE OF SERVICES: The District retains us as its Attorneys for the purposes of providing general legal advice and counsel as the District shall from time to time require. - 3. LEGAL FEES: The District agrees to pay for legal services as follows:
 - a. Paralegal services at \$72.00 per hour;
 - b. Associate attorneys' time at \$160.00 per hour; and,
 - c. Partner's time at \$170.00 per hour.

No fee will be charged for general clerical or secretarial services.

Bills will be sent monthly, stating clearly the amount, rate, basis for calculation, description and date of service. The District agrees to pay each bill within 30 days. Interest at the rate of 10% may be charged on any unpaid balance.

4. **COSTS**: All costs, disbursements and litigation expenses are the responsibility of the District. Costs are those expenses which must be paid to third parties or otherwise incurred in the course of the representation. Costs include, but are not limited to, court fees, service or process charges, photocopying services, notary fees, computer assisted legal research, long distance telephone charges, messenger and delivery fees, postage, in-office photocopying at \$.15 per page, facsimile charges, deposition costs, parking fees, mileage at IRS standard business rate, investigation expenses, consultant or expert witnesses and similar items. We agree to obtain written consent before incurring any outside services.

5. **NEGOTIATION OF FEES**: Attorneys' fees are not set by law, but rather are negotiable between the attorney and client.

6. ARBITRATION CLAUSE: Client and Law Firm are agreeing to have any and all disputes (except where Client may request arbitration of a fee dispute by the State Bar) that arise out of, or relate to this Agreement, including but not limited to claims of negligence or malpractice arising out of or relating to the legal services provided by Law Firm to Client, decided only by binding arbitration in accordance with the provisions of the Code of Civil Procedure section 1280 *et seq.*, and not by court action, except as provided by California law for judicial review of arbitration proceedings. AGREEMENT TO PROVIDE FOOD SERVICE BETWEEN A SUMMER FOOD SERVICE PROGRAM SPONSOR AND A FOOD SERVICE VENDOR

THIS AGREEMENT, entered into this 15th day of March 2010 by and between <u>TIGER</u> <u>WOODS LEARNING CENTER, 4281 Katella Ave., Suite 111, Los Alamitos, CA</u> <u>90720, herein after referred to as the Agency, and <u>ANAHEIM UNION HIGH SCHOOL</u> <u>DISTRICT, 501 S. Crescent Way, Anaheim, CA</u> 92801, herein after referred to as the **Vendor**.</u>

Whereas, it is not within the capability of the Agency to prepare specified meals under the Summer Food Service Program (SFSP); and

Whereas, the facilities and capabilities of the Vendor are adequate to prepare and deliver specified meals to the Agency's facility (ies); and

Whereas, the Vendor is willing to provide such services to the Agency on a cost reimbursement basis.

Therefore, both parties hereto agree as follows:

THE VENDOR AGREES TO:

1. Prepare unitized meals for *delivery inclusive* of milk or juice each day, in accordance with the number of meals requested and at the cost(s) per meal listed below:

Tiger Woods Learning Center at 520 North Gilbert, Anaheim, CA 92801, on the day before service.

- 2. Provide the Agency, for approval, a proposed cycle menu for the operational period, at least <u>10 days</u> prior to the beginning of the period to which the menu applies. Any changes to the menu made after Agency approval must be agreed upon by the Agency, approved by the California Department of Education (CDE) and documented on the menu records.
- 3. Ensure that each meal provided to the Agency under this agreement meets the minimum requirements as to the nutritional content as specified by the SFSP Meal Pattern, Schedule B, which is excerpted from the regulations 7 CFR Part 225.16 or an approved National School Lunch Program (NSLP)/School Breakfast Program (SBP) option. NSLP/SBP vendors may use the same menu planning

option they use during the school year in lieu of using the SFSP meal pattern. Snacks will meet the SFSP meal pattern.

- 4. Maintain full and accurate records which document: (1) the menus were provided to the Agency during the term of this agreement; (2) a listing of all components of each meal; and, (3) an itemization of the quantities of each component used to prepare said meal. The Vendor agrees to provide meal preparation documentation by using yield factors for each food item as listed in the United States Department of Agriculture (USDA) Food Buying Guide when calculating and recording the quantity of food prepared for each meal.
- 5. Maintain such cost records as invoices, receipts and/or other documentation that exhibit the purchase, or otherwise availability to the Vendor, of the meal components and quantities itemized in the meal preparation records.
- 6. Maintain, on a daily basis, an accurate count of the number of meals, by meal type, prepared for and delivered by the Vendor. Meal count documentation must include the number of meals requested by the Agency.
- 7. Allow the Agency to increase or decrease the number of meal orders, as needed, when the request is made within <u>3 days</u> of the scheduled delivery time. Unless volume exceeds 200 meals.
- 8. Present to the Agency an invoice accompanied by reports no later than the <u>10th</u> <u>day</u> of each month, which itemizes the previous month's delivery. The Vendor agrees to forfeit payment for meals which are not ready within one (1) hour of the agreed upon delivery time, are spoiled or unwholesome at the time of delivery, or do not otherwise meet the meal requirements contained in this agreement. In cases of nonperformance or noncompliance on the part of the Vendor, the Vendor shall pay the Agency for any excess costs the Agency incurs by obtaining meals from another source.
- 9. Provide the Agency with a copy of current health certifications for the food service facility in which it prepares meals for the SFSP. The Vendor shall ensure that all health and sanitation requirements of the California Uniform Retail Food Facilities Law, Chapter 4 of the California Health and Safety Code, are met at all times.
- 10. Operate in accordance with current SFSP regulations. Comply with all other USDA regulations regarding service vendors including those specified for commercial food service if applicable.
- 11. Retain all required records for a period of three (3) years after the end of the fiscal year to which they pertain (or longer, if an audit is in progress). Upon request, make all accounts and records pertaining to the agreement available to a certified public accountant hired by the Agency, representatives of the CDE, USDA, and

the Office of Inspector General for audits or administrative reviews at a reasonable time and place.

- 12. Not subcontract for the total meal, with or without milk, or for the assembly of the meal.
- 13. Be paid by the Agency for all meals delivered in accordance with the agreement. Neither the CDE nor the USDA will assume any liability for payment of differences between the number of meals prepared for delivery and/or pickup by the Vendor and the number of meals served by the Agency that are eligible for reimbursement.

THE AGENCY AGREES TO:

- 1. Request by telephone no later than <u>3 days</u>, an accurate number of meals to be delivered/picked up by the Agency each day. Notify the Vendor of necessary increases or decreases in the number of meals ordered within <u>3 days</u> of the scheduled delivery/pickup time. Errors in meal orders made by the Agency shall be the responsibility of the Agency.
- 2. Ensure that an Agency representative is available at each delivery site, at the specified time on each specified delivery day to receive, inspect, and sign for the requested number of meals. This individual will verify the temperature, quality, and quantity of each meal service delivery. The Agency assures the Vendor that this individual will be trained and knowledgeable in the record keeping and meal requirements of the SFSP and with local health and safety codes.
- 3. Provide personnel to serve meals, clean the serving and eating areas, and assemble transport carts and auxiliary items for pickup by the Vendor (if applicable) no later than the next morning.
- 4. Notify the Vendor, within <u>60 days</u> of receipt of the next month's proposed cycle menu, of any changes, additions, or deletions.
- 5. Provide the Vendor with a copy of 7 CFR Part 225.16; the SFSP Meal Pattern, Schedule B; the USDA Food Buying Guide; and all other technical assistance materials pertaining to the food service requirements of the SFSP. The Agency will, within 24 hours of receipt from the NSD, advise the Vendor of any changes in the food service requirements.
- 6. Pay the Vendor by the <u>30th day</u> of each month the full amount as presented on the monthly-itemized invoice. Notify the Vendor within 48 hours of receipt of any discrepancy in the invoice. Pay the Vendor for all meals delivered/picked up in accordance with the agreement. Neither the California Department of Education nor USDA assume any liability for payment of the difference between the number

of meals prepared, picked up by the Agency, delivered by the Vendor, and the number of meals served by the Agency that are eligible for reimbursement.

TERMS OF THE AGREEMENT:

This agreement will take effect commencing on April 1, 2010 and shall end on June 30, 2011. This agreement may be terminated by either party giving notice at least 30 days prior to the date of termination. The Agency shall have the option to cancel this contract if the federal government withdraws funds to support the SFSP. It is further understood that in the event the contract is cancelled, the Agency shall be responsible for meals that have already been assembled, delivered/picked up in accordance with this agreement.

2.1 Personnel/ Staffing per event – Mr. Holcomb described the process by which staffing is determined, and also indicated that this process still needs to be improved. It was suggested that, along with date information, we provide staffing expectations for each event. It was also noted that for each event, security must be covered (2 @ Anaheim & Kennedy, 1 @ Loara & Western). Security is charged to the site using the facility. Security is defined as 1 Campus Safety Aide. Custodial costs/assignments are up to John Adams to assign, as needed.

2.2 Facilities Usage Calendar

Calendar dates will be set at the district level on April 26. It was expressed that potential calendar conflicts might be better resolved if there were a representative present from the Instrumental Music Dept. Chairs. Mr. Navarro stated that one impediment to a stable calendar was those who wanted to make changes after the meeting. It was suggested that directors meet prior to the calendar meeting and forward their requests to the principals, so that the district administrators would have someone directly responsible (principals) at each site. It was also suggested that a director representative be present when the principals review their calendar requests, so as to better advise principals of potential conflicts they might not foresee. Mr. Holcombe also added that he must manage available support personnel for many dates. It was then suggested that along with calendar dates, directors provide anticipated personnel needs.

2.3 Non-School/ Holidays/Vacation Events Policy

It was asked why events are not scheduled during these times. Mr. Holcomb added that John Adams' staff needs vacation time, too. This is an issue of personnel availability, and is workable with advance notice. Summertime usage, while difficult (due to furlough and vacation days) is also workable, with advanced notice.

2.4 Clarification of "non-school events" - If school students are performing, it is considered a school event. If the event is specifically a "fundraiser" (run by boosters to make money for the school program, etc.), then it is considered an outside, or "non-school" event.

3.0 Transportation Concerns

3.1 Billing practices (Timeliness & consistency) were addressed by Mr. Jesse. According to Mr. Jesse, cutbacks in personnel who do the billing have affected accuracy. Mr. Jesse suggested a day-by-day breakdown to be emailed to a representative. A new system, where billing info is in by the 10th of each month, will be implemented soon. Current cost is \$60/hr. Some directors noted that transportation was being billed to the incorrect account. An email to Mr. Jesse may clarify this. Sat, Sun, and holidays have a 4 hour minimum. If a trip is estimated longer than 8 hours, it was suggested that a "pick up & drop off" be arranged, so that only 8 hours will be billed. It was noted that most drivers are back in the yard by 8:30, so to avoid the extra hour of billing, request a bus at 8:30 when possible. Budget information for next year should be available sometime in May.

3.2 Conflicting amounts for several vehicles per same event – the time is billed (due to contract) starting when the driver finishes their route. Larger discrepancies should be brought to John Jesse's attention directly (as per Mr. Jesse's request). There is no additional one-hour charge when a driver is coming to you off of their route. Overtime, by contract, must be equitably divided by bus/driver, and that prevents efficiency of bus assignments. It was unanimously agreed that the drivers have provided excellent "customer service".

4.0 Band Spectacular and related Issues

4.1 Steve Kraus expressed concerns that without a Curriculum Administrator, some important events, such as the Awards Out Loud program and the Band Spectacular, were affected by the lack of communication with various departments within the district. Dr. Navarro suggested having 2 AP's assigned to the event, and indicated that he will help assign them for next year.

4.2 Need for a district connection with authority to oversee district events - Bill Schroeder reiterated the need for the Instrumental Music directors to have a more direct and consistent form of communication with district personnel. Dr. Navarro suggested that he be present several times a year for Instrumental Music Department Chairperson's meetings, which was met with a very favorable response. It was suggested that Dr. Navarro include the first meeting of the year as one of those at which he is present.

5.0 Timeline for solutions

5.1 Directors – Bring Instrumental music calendar requests to April Dept. Chair meeting to coordinate them, then forward requests to principals and Mr. Holcomb's office. Include support staff needs, where applicable.

5.2 Mr. Holcomb and District personnel – Set facilities usage calendar on April 26, Provide transportation budget information in May

5.3 Mr. Jesse – Implement regular and timely monthly billing system.

5.5 Dr. Navarro – attend Instrumental Music Dept. Chair meetings as agenda items dictate; specifically, the September, October and January meetings.

6.0 Meeting Adjourned- the meeting was adjourned at 5:00PM. The next meeting will be on April 13, 2010 at Savanna HS, 3:30 PM.

Insurance Committee Meeting February 16, 2010

Minutes

IV. What is a JPA or Trust?

Mike DeMore discussed the differences between a joint powers authority (JPA) and a trust. A JPA allows public agencies to join together to provide more effective or efficient services for lower premiums to members. A JPA is governed by a board of trustees which may include both labor and management representatives. A trust is comprised of a common set of employers and employees who come together to purchase healthcare benefits. Trusts are tax-exempt and also governed by a board of trustees with equal representation by management and labor.

V. Pooled Purchasing

Pooling to purchase healthcare can benefit small organizations that are selffunded. By pooling together, they are able to avoid state-level regulation and experience reduced administration fees charged by the insurance carriers. While joint purchasing can provide benefits such as increased purchasing power/leverage, administrative savings, and more predictable renewals because of less fluctuation, there is a downside. By joint purchasing, the district would have less autonomy and limited input and plan design options. Also, it can be difficult to obtain experience data for an individual employer, and rules for exiting the pool may restrict how and when a member can terminate membership and coverage.

VI. Consumer Driven Health Plans (CDHP)

CDHP is a type of high-deductible health plan with an individual account that helps pay for routine services. There are two CDHP plans: 1) Health

Reimbursement Account (HRA), which is an unfunded account held by the employer; and, 2) Health Savings Account (HSA), which is funded by the Insurance Committee February 16, 2010 Page 2

employee, employer, or both, and is owned by the employee. Having a CDHP encourages consumers to become more responsible and better educated about their healthcare program. The CDHP cost comparison was discussed at great length, as well as the mandated limits and CDHP plan design.

VII. Follow up on January Presentation/Minimally Invasive Surgery

Ivette brought additional information to the group regarding minimal invasive surgeries. The Insurance Committee decided to go forward and deliver unbranded educational programs to our employees to increase awareness of biopsy/diagnostic and surgical treatment options. Each month the information sent to employees will be on a different topic.

VIII. Topics for March 16, 2010 meeting

InformedRx Presentation: Results for the 2009 plan year. Review the PPO underwriting projections. Find ways to encourage employees to enroll in the PPO plan.
