EDUCATIONAL CONSULTING AGREEMENT AMENDMENT

THIS AGREEMENT AMENDMENT is made and entered into this:

in reference to the Consulting Agreement by and between

Orange County Department of Education

Independent Contractor, hereinafter referred to as "Consultant" and the Anaheim Union High School District, hereinafter referred to as "District" dated and Board approved:

June 26, 2008

and amends said Consulting Agreement as follows:

The "Orange County Department of Education (OCDE) School Leadership Teams" develop the capacity of schools by focusing on developing teacher leaders. These teams are designed to facilitate interactions within school teams, with the ultimate goal of increasing student achievement. Training occurs through seminars and collaborative work experiences. School leadership teams make a long-term commitment to facilitate the improvement of student learning opportunities. The goals of the School Leadership Team are: to increase leadership skills necessary for the implementation of school reform strategies; to improve student achievement; to meet the Academic Performance Index (API) and Adequately Yearly Progress (AYP) targets; and, to exit Program Improvement. The OCDE School Leadership Team meets five times each school year, for two years. The sessions are organized around research-based strategies for whole-school reform.

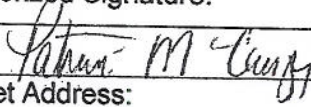
On June 26, 2008, the Anaheim Union High School District Board of Trustees approved OCDE leadership training for the following schools: Katella High School, Loara High School, Ball Junior High School, Brookhurst Junior High School, Walker Junior High School, and Dale Junior High School. The cost for the above schools is \$60,000, paid for by Title II funds. Services are provided July 1, 2008, through June 30, 2009, in which 60 administrators and teachers each will receive five days of training.

Since the original agreement was approved on June 26, 2008, two additional schools, Oxford Academy and Magnolia High School, will participate in the training upon Board approval. The cost for the additional schools is \$20,000. Services will be provided September 1, 2008, through June 30, 2009, in which 20 additional administrators and teachers will each receive five days of training, to be charged to Title II funds.

Total amount of the entire agreement will be \$80,000.

All other terms and conditions of the original agreement will remain in force.

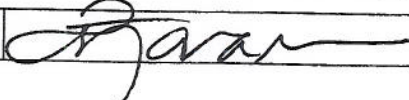
